KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of **TEN DOLLARS AND NO/100 (\$10.00) DOLLARS, and other good and valuable considerations**, the undersigned grantor in hand paid by the undersigned grantees, by the receipt whereof is acknowledged, the said **William Levins** does grant, bargain, sell and convey unto the said **Odell Reeves (Levins)**, together with every contingent remainder and right of reversion, and to the following described property, lying and being situated in Shelby County, Alabama, and being more particularly described as follows:

Parcel 1

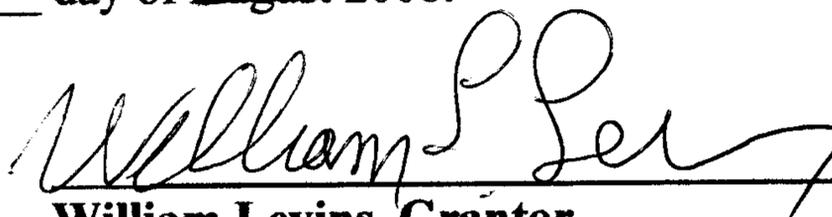
A portion of the S $\frac{1}{2}$ of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 24, T-20-S, R-3-W more particularly described as follows:

Begin at the N. E. corner of the S $\frac{1}{2}$ of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 24, T-20-S, R-3-W and run westerly along the north side of the said S $\frac{1}{2}$ for 265.15 ft. to a point on the east right of way of a service road for I-65 (said point being Station 24+69.51 as per State Highway Dept. R.O.W. survey markers), then turn an angle of 117 deg 53 min 41 sec to the left and run southeasterly along the east R.O.W. of said road for 230.63 ft. to Station 23+38.88 of said R.O.W., then turn an angle of 62 deg 06 min 14 sec to the left and run easterly for 162.24 ft. to a point on the east side of the S $\frac{1}{2}$ of the said NE $\frac{1}{4}$ of the NE $\frac{1}{4}$, then turn an angle of 91 deg 24 min 18 sec to the left and run northerly along the east side of the said S $\frac{1}{2}$ for 203.89 ft. back to the point of beginning.

The above described parcel contains 1.00 acres and is subject to the easements, rights of ways, and restrictions of record.

TO HAVE AND TO HOLD unto the said **Odell Reeves (Levins)** her successors and assigns, forever. And I do, for myself and for my heirs, executors and administrators, covenant with the said Grantee, his heirs and assigns; that I am lawfully seized in Fee Simple of said premises; that they are free from all encumbrances; and that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to the said Grantee, her heirs, executors and assigns forever, against all lawful claims of all persons.

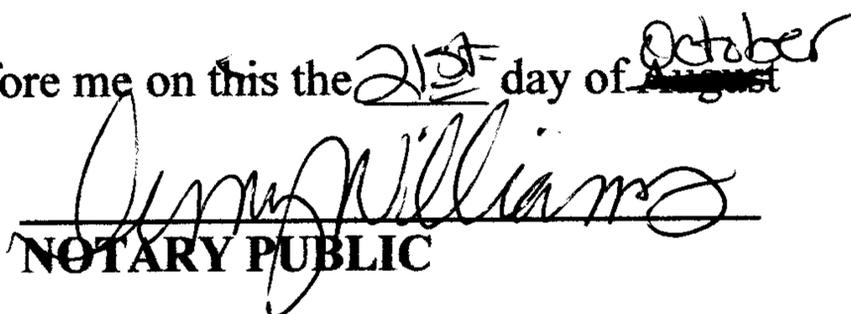
