This case having come before the Court on the Motion for Default Judgment filed by the Plaintiff due to the Defendants failure to answer and/or defend this action, and the Court having reviewed the facts determines that the Defendants are in default, it is hereby:

ORDERED, ADJUDGED AND DECREED, that the Plaintiff recover of the Defendants the sum of \$20,806.45 along with all costs of this action and interest at the rate of eighteen (18%) percent per annum from the date of this judgment. The Court further orders that the lien filed by the Plaintiff for work performed upon the Defendants' property and set forth in Plaintiff's complaint is hereby confirmed in favor of the Plaintiff and against the Defendants and Defendants' property as follows:
