ORDERED, ADJUDGED AND DECREED that the Plaintiff have and recover of all Defendants the sum of Five Thousand Nine Hundred Fifty-One Dollars and Ninety-Five Cents (\$5,951.95) as principal claimed in this proceeding with the addition of One Thousand Nine Hundred Eighty-Four Dollars and Five Cents (\$1,984.05) as attorney's fees for a total of Seven Thousand Nine Hundred Thirty-Six Dollars (\$7,936.00). The Court further confirms Plaintiff's lien in the following properties:
