SUBJECT TO all right of ways, easements and restrictions which may exist as a matter of record or exist de facto.

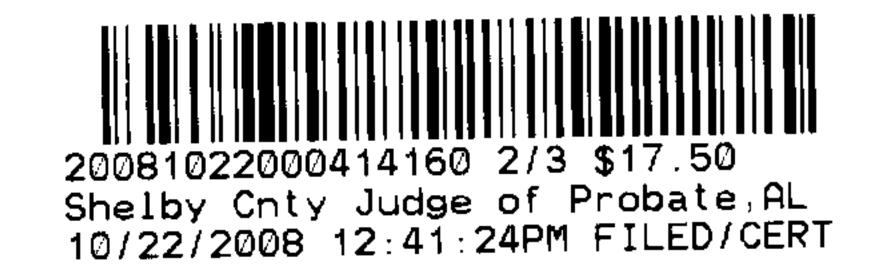
GRANTOR RESERVES unto itself, its agents, employees, successors and assigns, the right to use said right-of-way.

Grantee hereby agree to indemnify and hold harmless Grantor for any and all liability for personal injuries, property damage, or for loss of life or property resulting from, or in any way connected with, the condition or use of the above described property, or any means of ingress thereto or egress therefrom, regardless of whether or not such injuries or damage are alleged to be caused in whole or in part by Grantee, it agents, employees or assigns.
