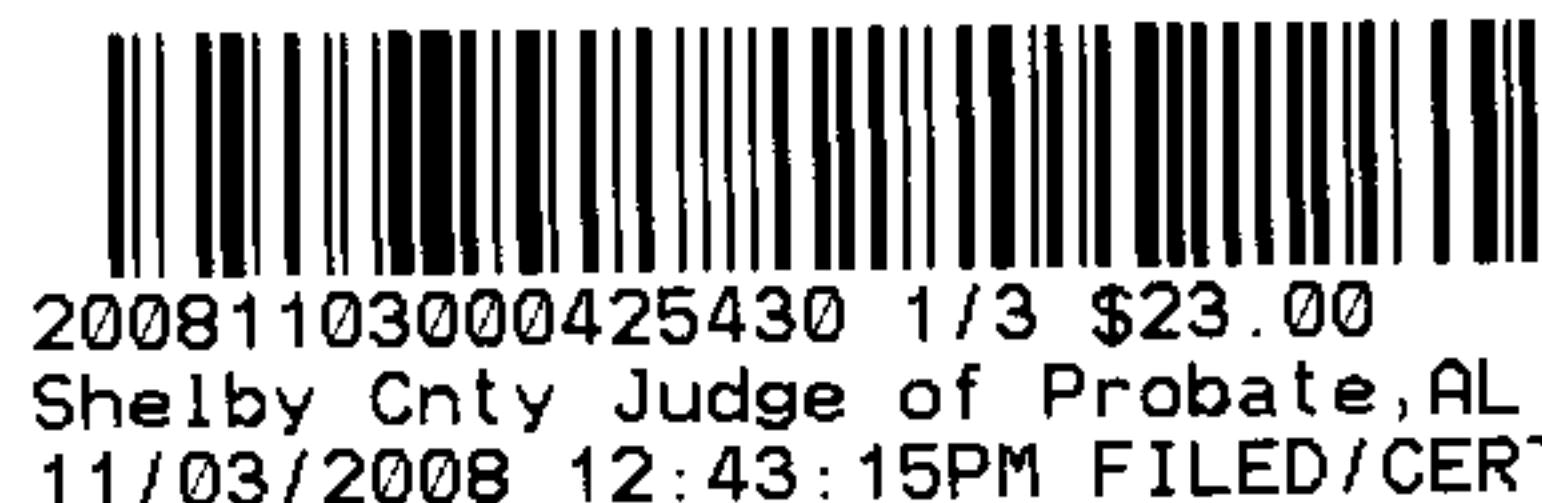



presents, and we hereby waive our right to claim personal property exempt under the laws of Alabama.

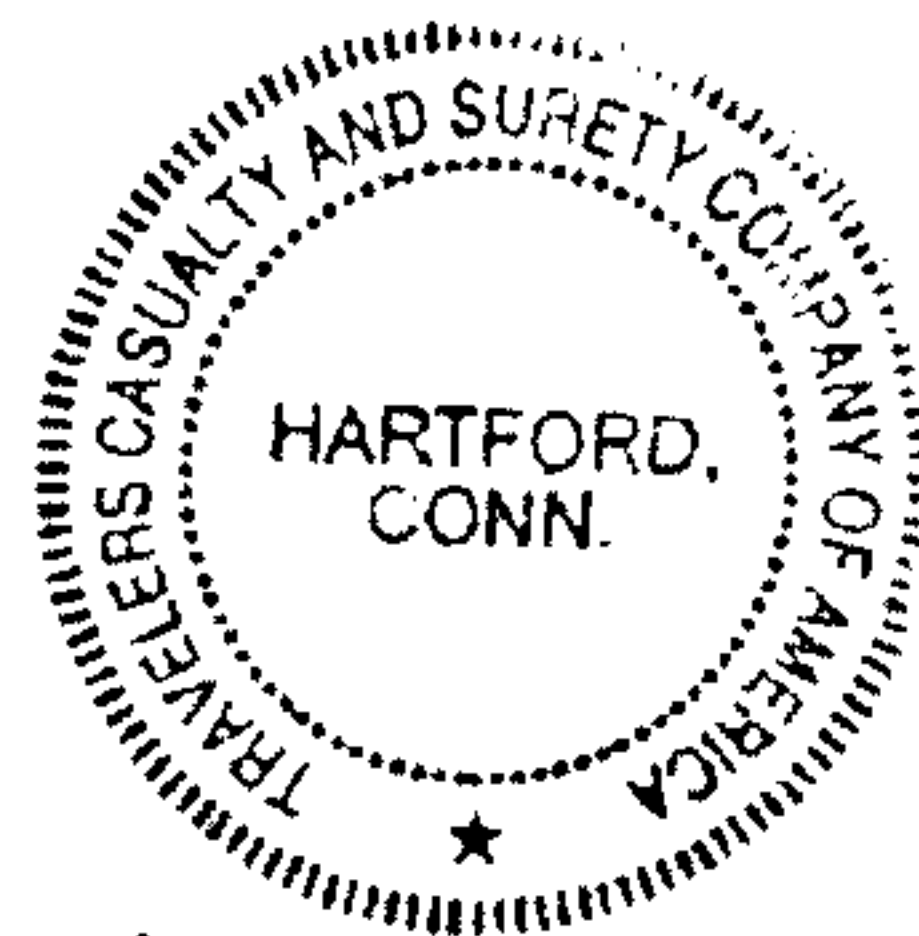
THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, That whereas, the above bound Principal was duly appointed to the office of

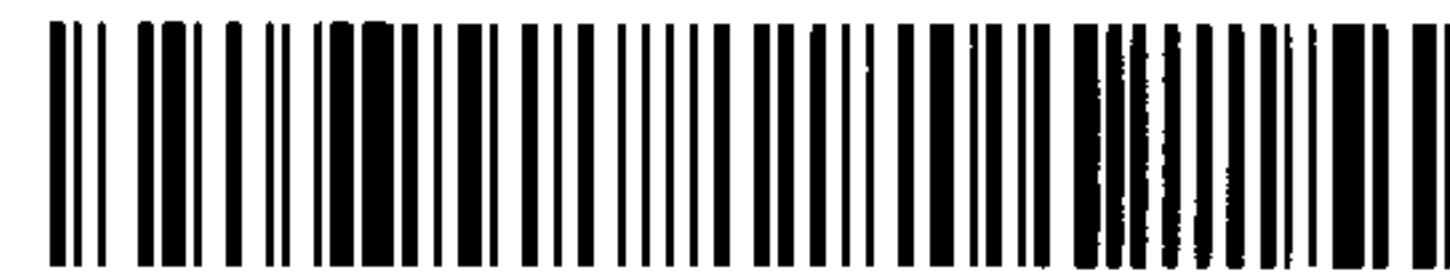

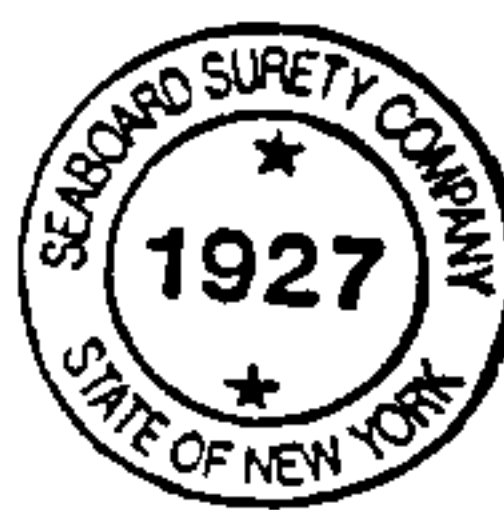

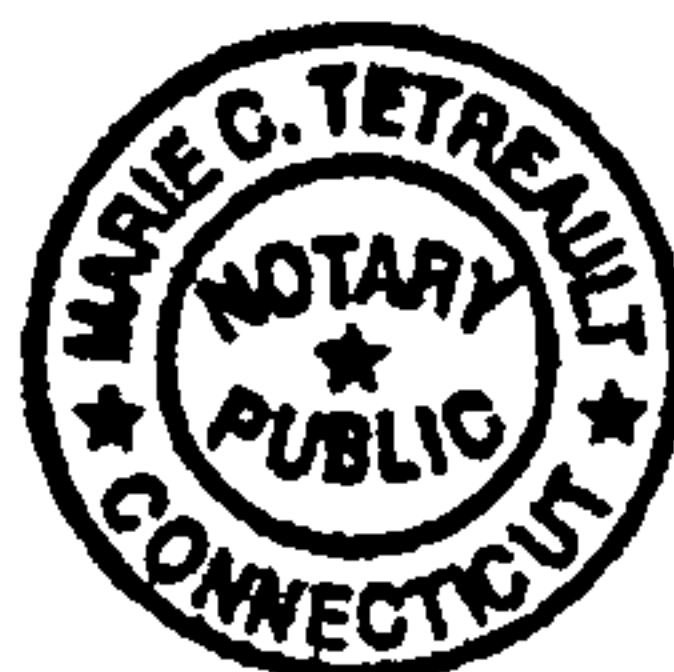
