

**ARTICLES OF ORGANIZATION

Management


5.01 **Management** The property, business and affairs of the limited liability company shall be managed by its members.



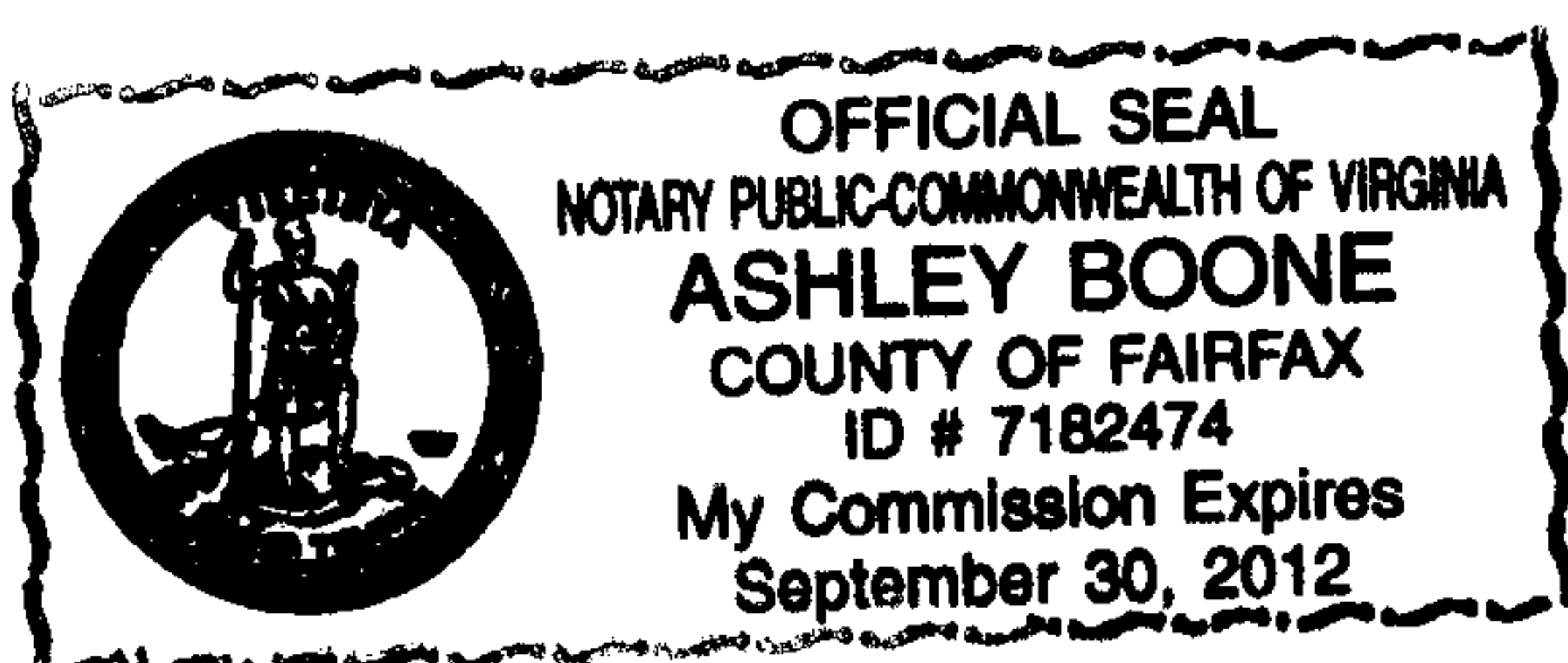
