FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on January 13, 2005, Brian Scott Henderson and spouse, Kelly R. 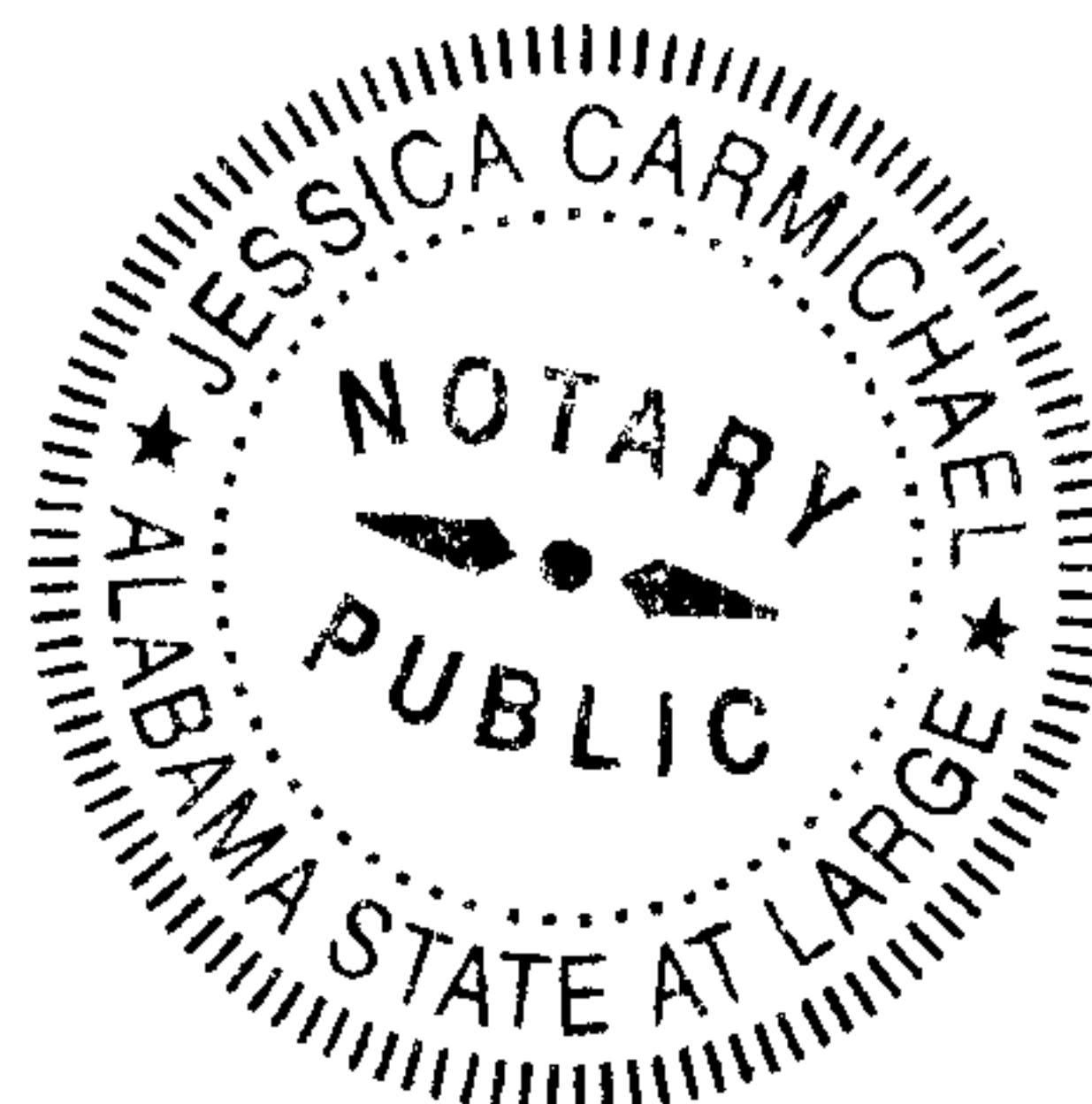
