KNOW ALL MEN BY THESE PRESENTS, THAT:

WHEREAS, heretofore on, to-wit: January 19, 2007, Shelby Homebuilders, Inc., mortgagor, executed a certain mortgage to BancorpSouth Bank which said mortgage is recorded in Instrument No. 20070125000039500, in the Office of the Judge of Probate of Shelby County, Alabama, and,

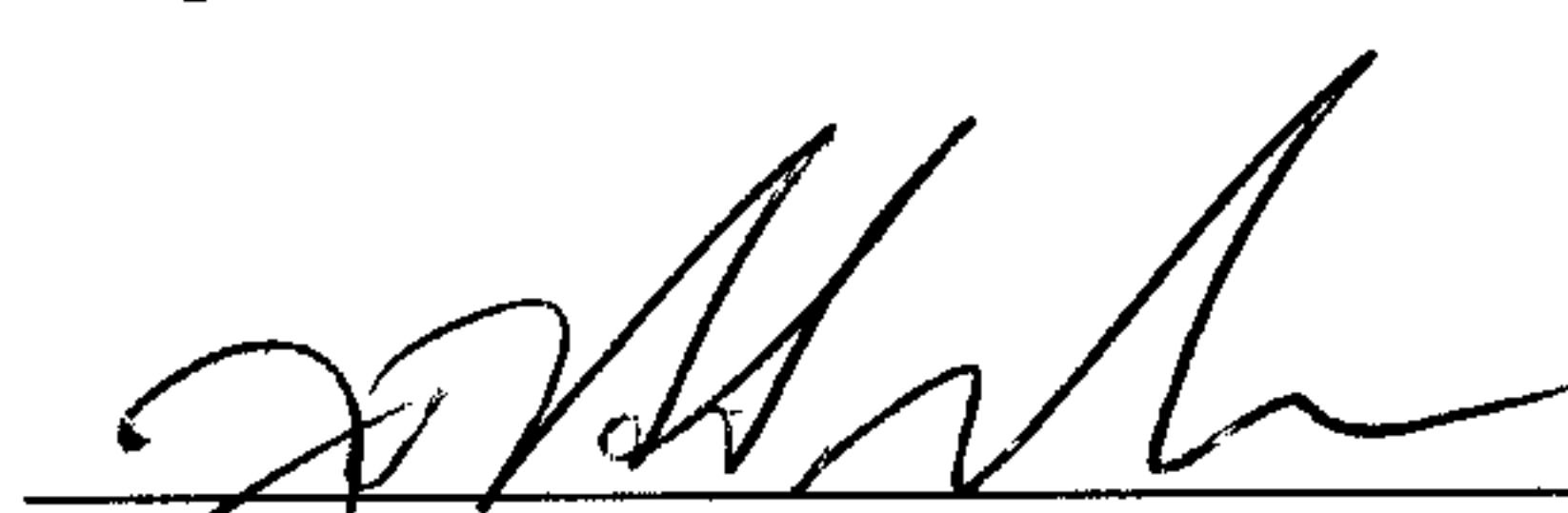

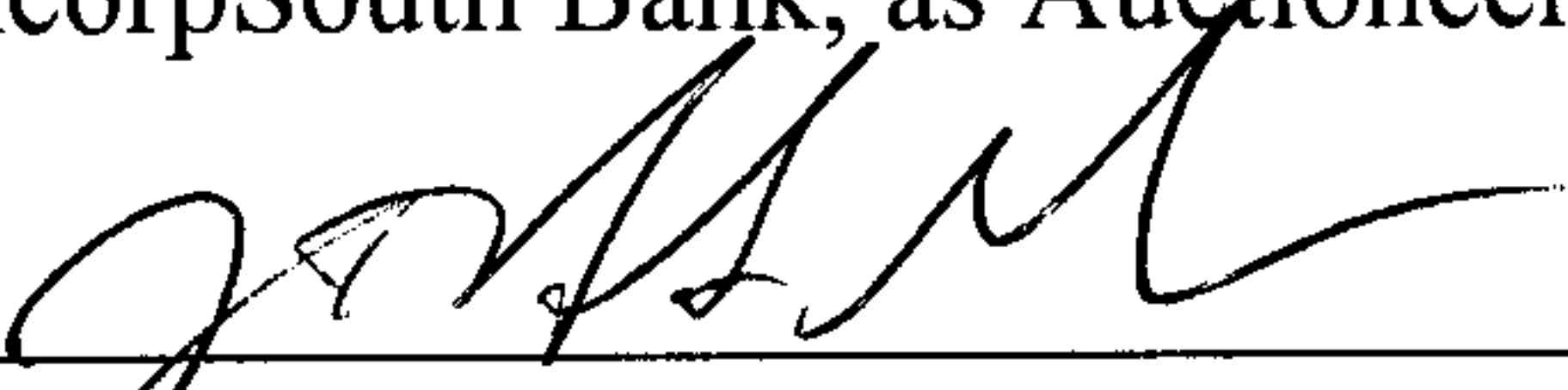

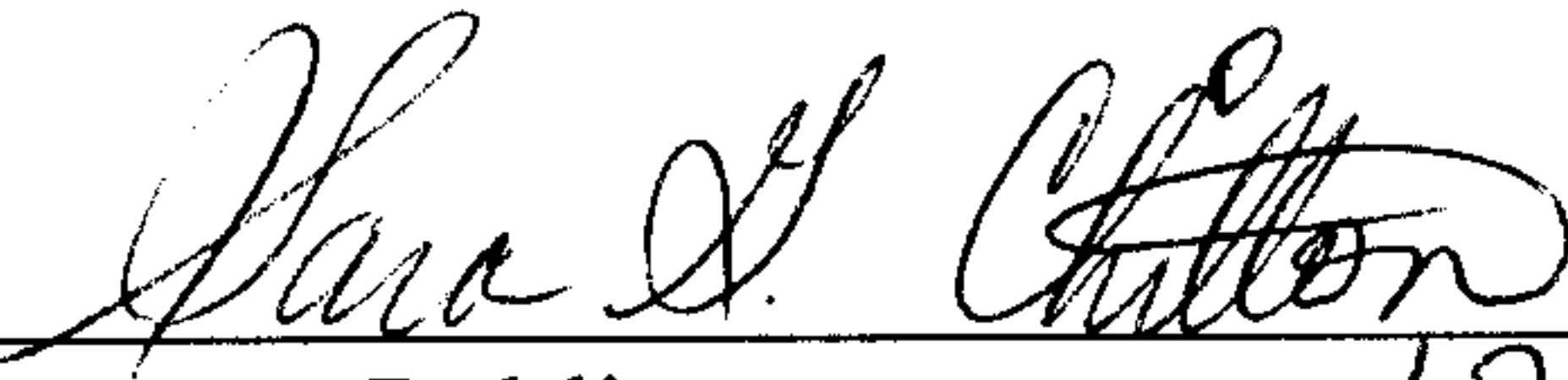
