Article VI Upon the death or bankruptcy of a member of the limited liability company, the remaining member in interest may continue to carry on the business of the limited liability company. Upon the voluntary resignation, expulsion, or dissociation of a member of the limited liability company, such member shall have the power to dissolve the limited liability company.
