WHEREAS, heretofore on September 25, 2006, **Heather R. Paulson, wife and husband, John F. 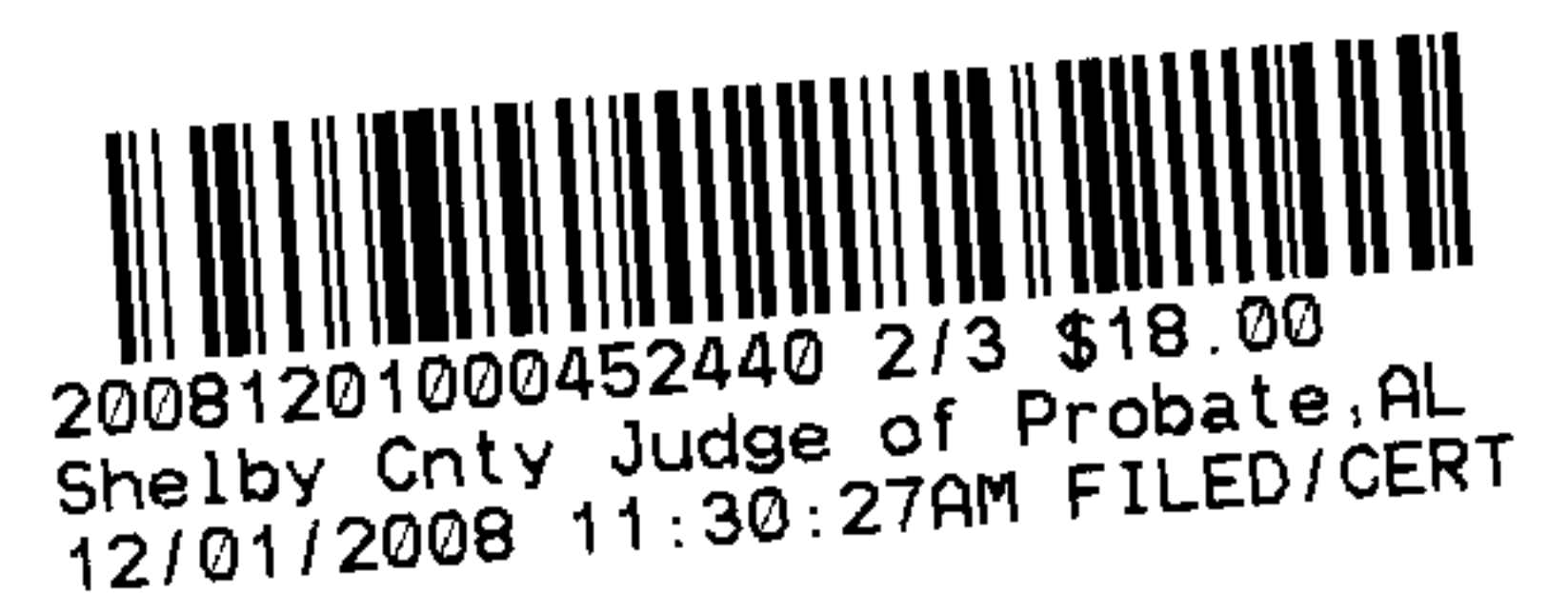
