THIS FORECLOSURE DEED made this 25th day of November, 2008, between FRANK V. SANDERS, a married man, along with his wife, TRACY SANDERS, Parties of the First Part, and CITIBANK, N.A., AS TRUSTEE, Party of the Second Part;

WITNESSETH:

WHEREAS, the said FRANK V. SANDERS, a married man, along with his wife, TRACY SANDERS, heretofore executed to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. 
