THIS FORECLOSURE DEED made this 25th day of November, 2008, between DAVID TRUESDALE, a married man, and STEPHANIE TRUESDALE, Parties of the First Part, and DEUTSCHE BANK NATIONAL TRUST COMPANY, AS TRUSTEE, IN TRUST FOR THE REGISTERED HOLDERS OF AMERIQUEST MORTGAGE SECURITIES INC., ASSET-BACKED PASS-THROUGH CERTIFICATES, SERIES 2004-R7, Party of the Second Part;

WITNESSETH:

WHEREAS, the said DAVID TRUESDALE, a married man, and STEPHANIE TRUESDALE, heretofore executed to AMERIQUEST MORTGAGE COMPANY, herein called the Mortgagee, a certain mortgage dated May 22, 2004, and recorded in Document No. 20040601000291190, Probate Records of Shelby County, Alabama, which conveyed the hereinafter described property to secure the indebtedness evidenced by a note, payable in installments, therein described; and


