SPECIFIC POWER OF ATTORNEY

If, following execution of this power of attorney, a court of my domicile appoints a guardian, curator, or other fiduciary charged with the management of all of my property, or all such property except specified exclusions, the court shall appoint my attorney-in-fact, **BETTY DIANE LAWHORN**, except for good cause or disqualification.

This specific power of attorney shall be effective for a period of six (6) months after execution hereof.


