

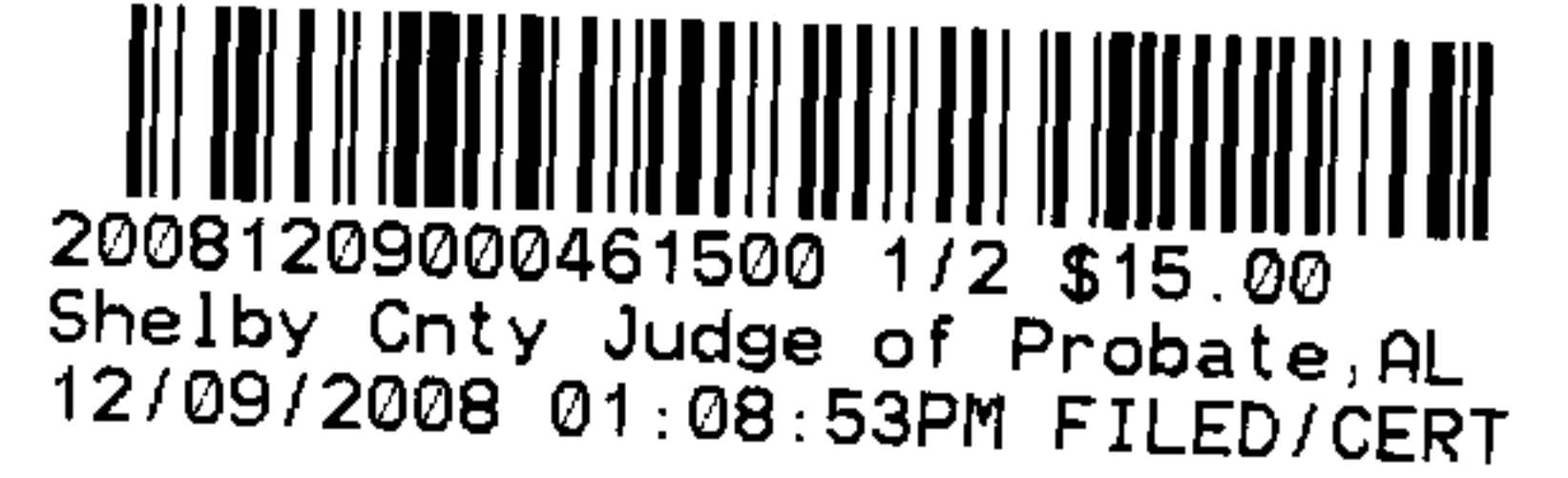
SPECIAL WARRANTY DEED

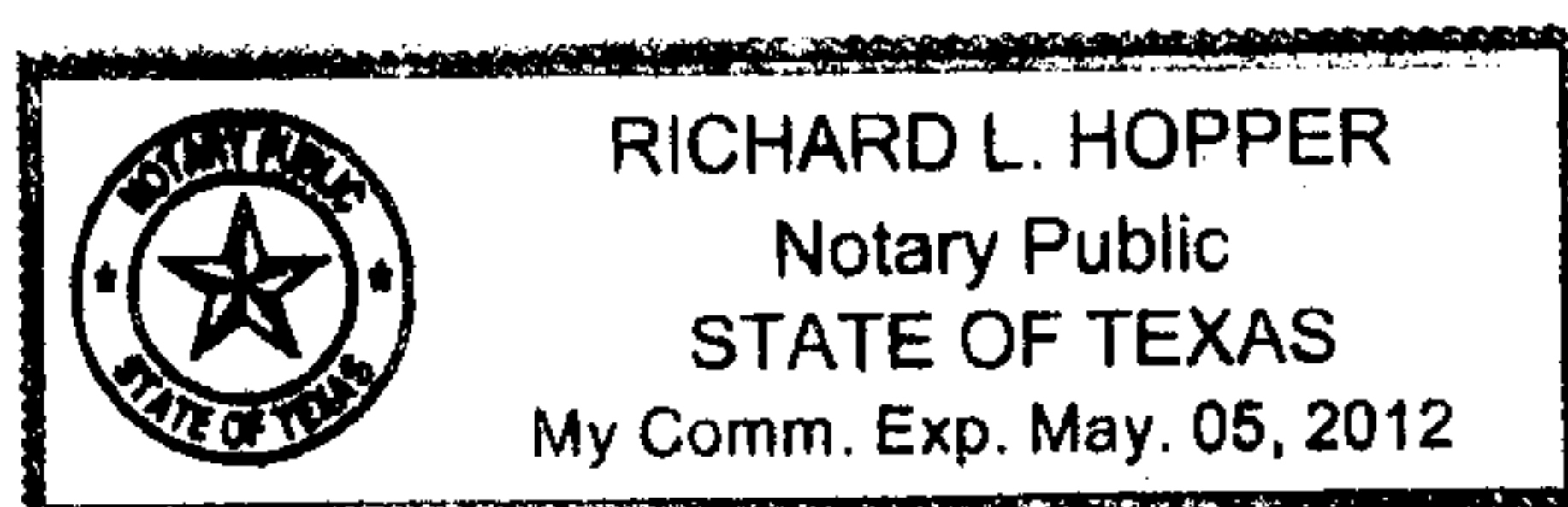
