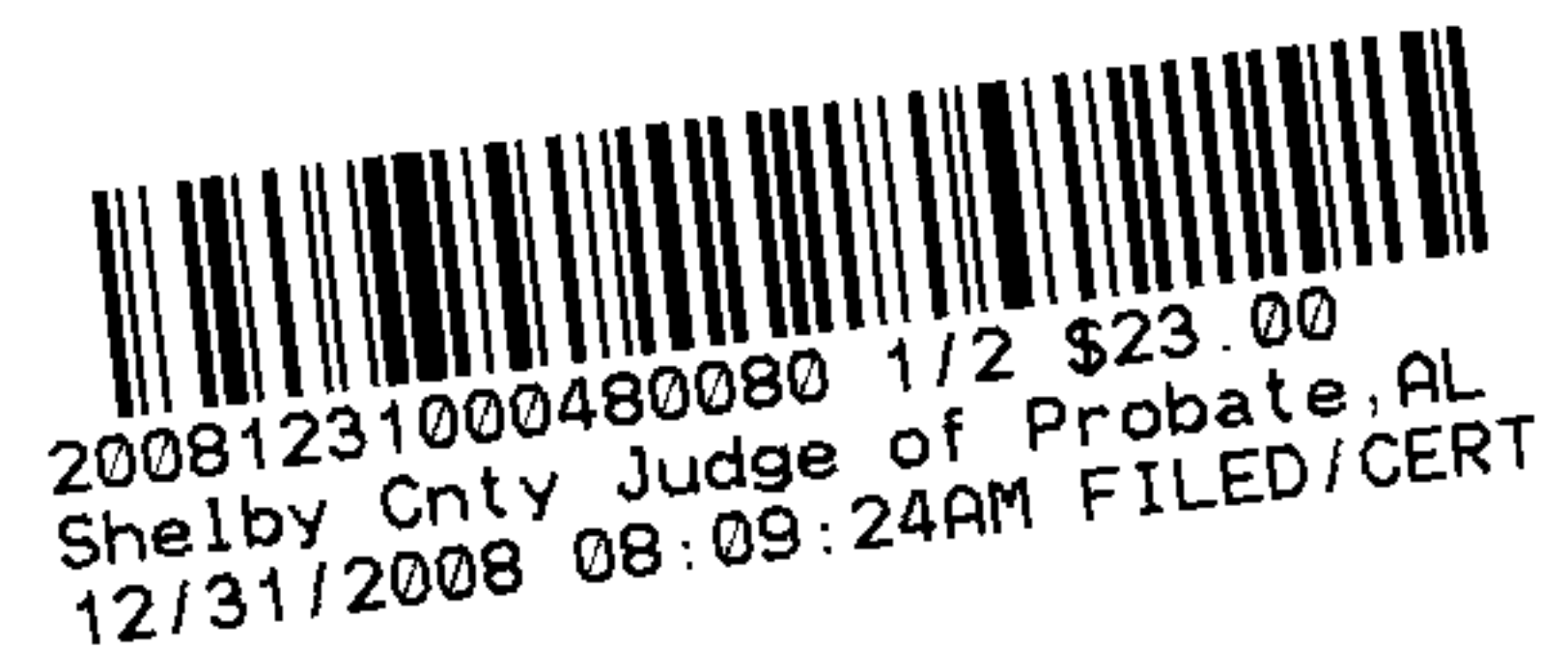

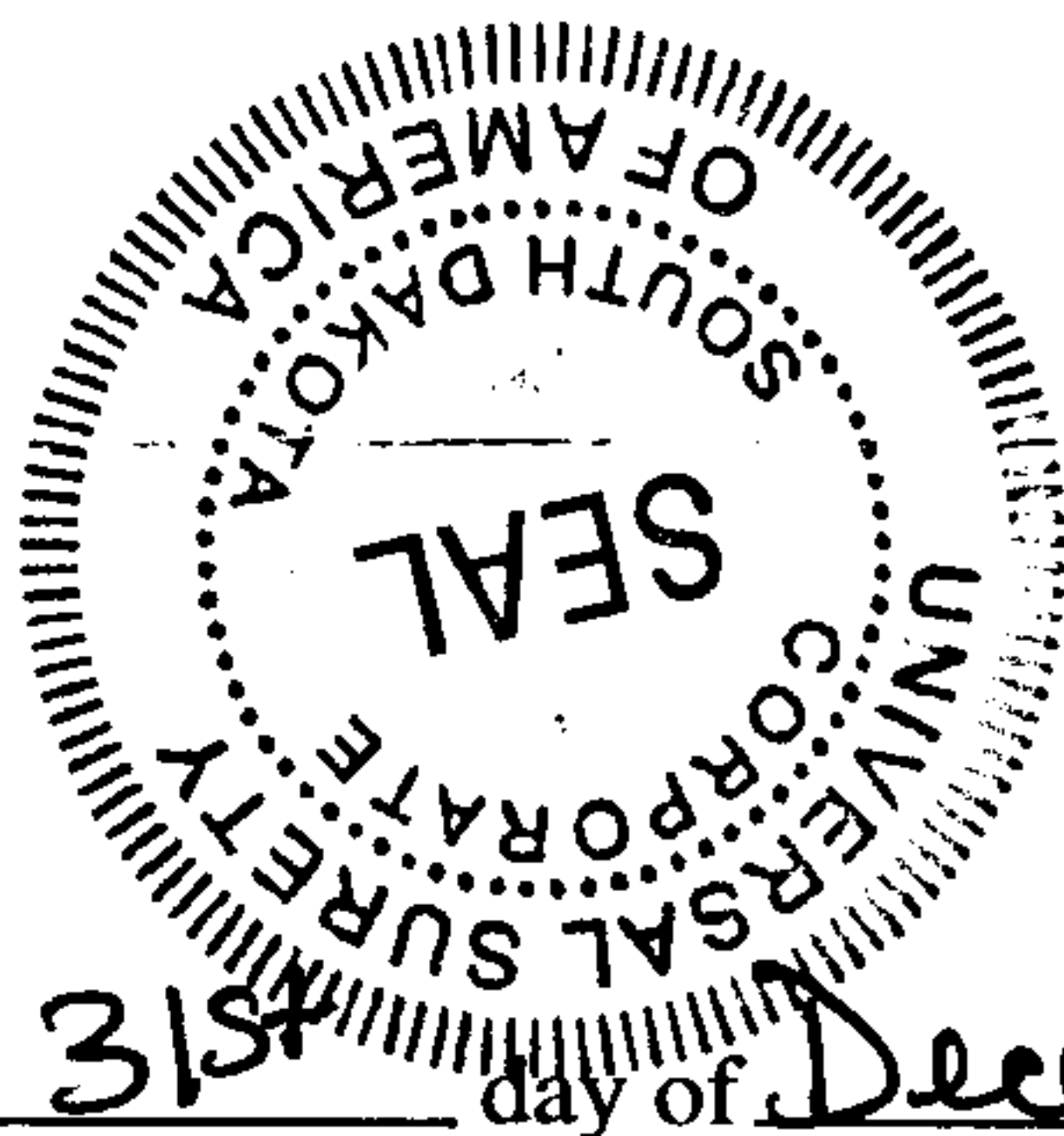
KNOW ALL PERSONS BY THESE PRESENTS:

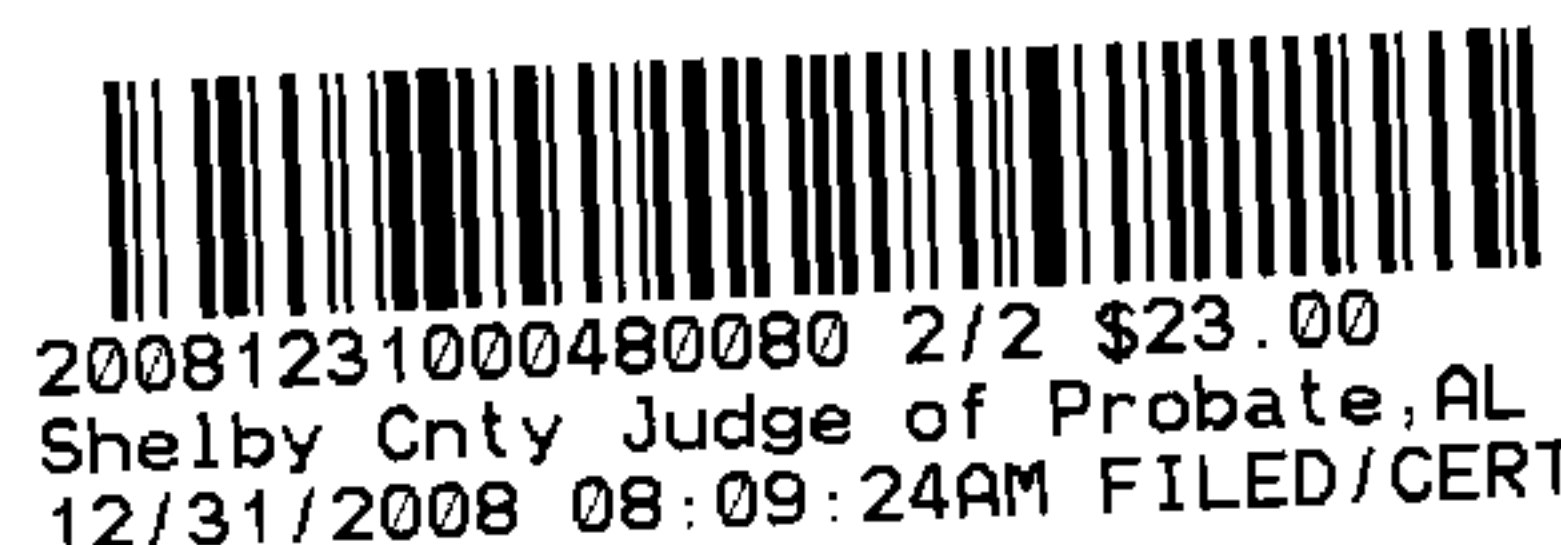

POWER OF ATTORNEY

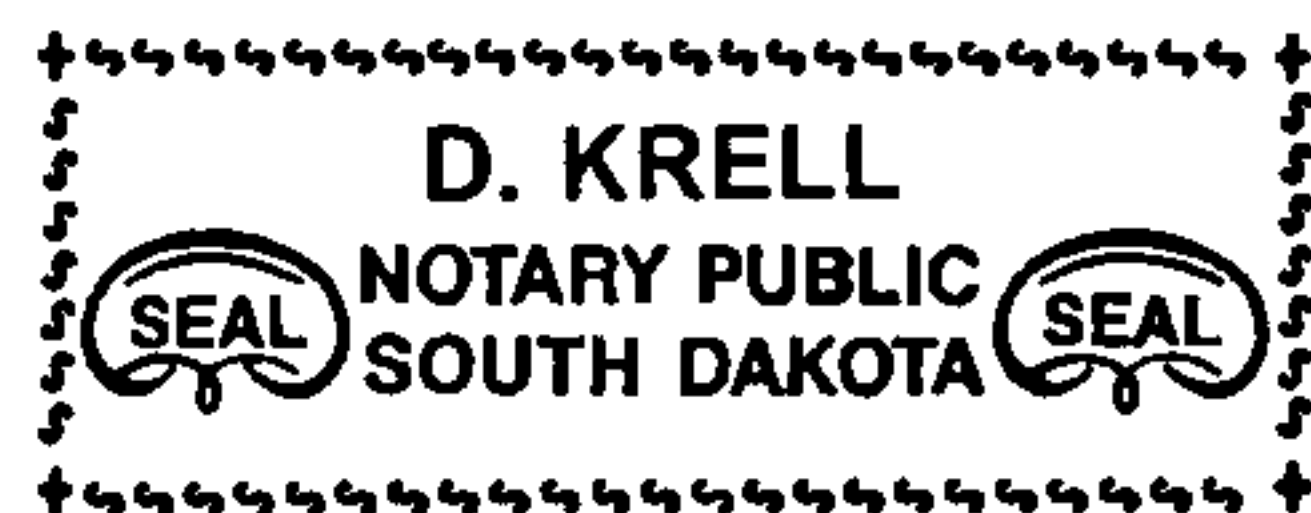
