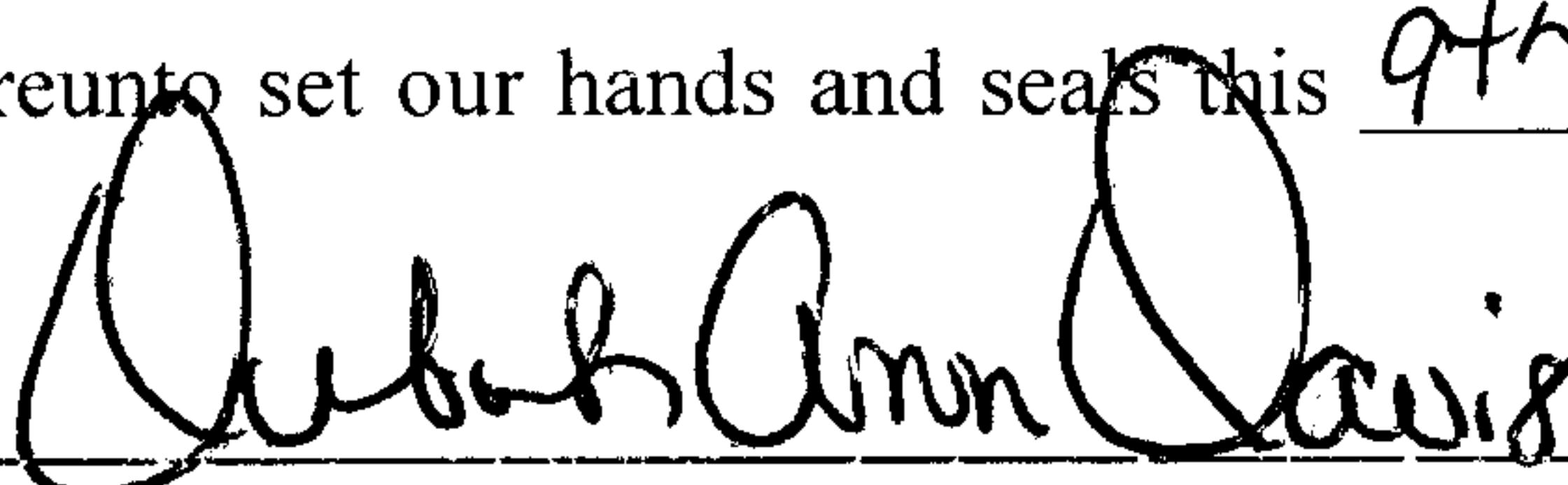

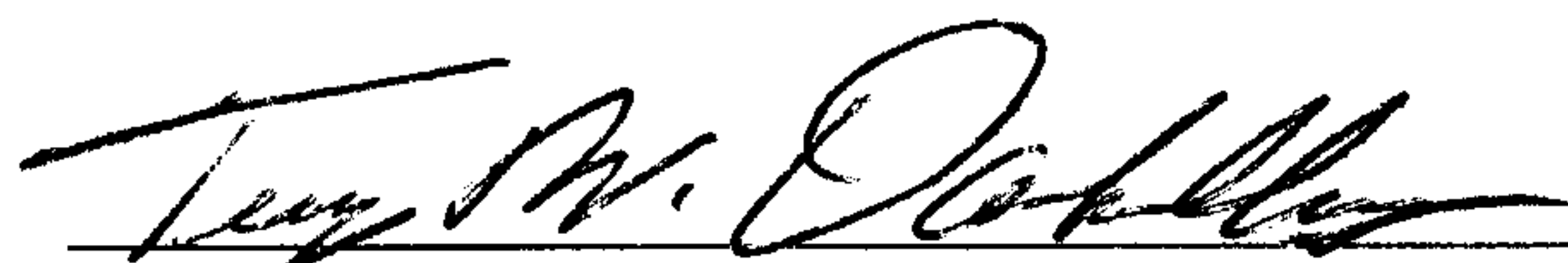
The above-described real estate is not now nor has it ever been the homestead of the Grantors.

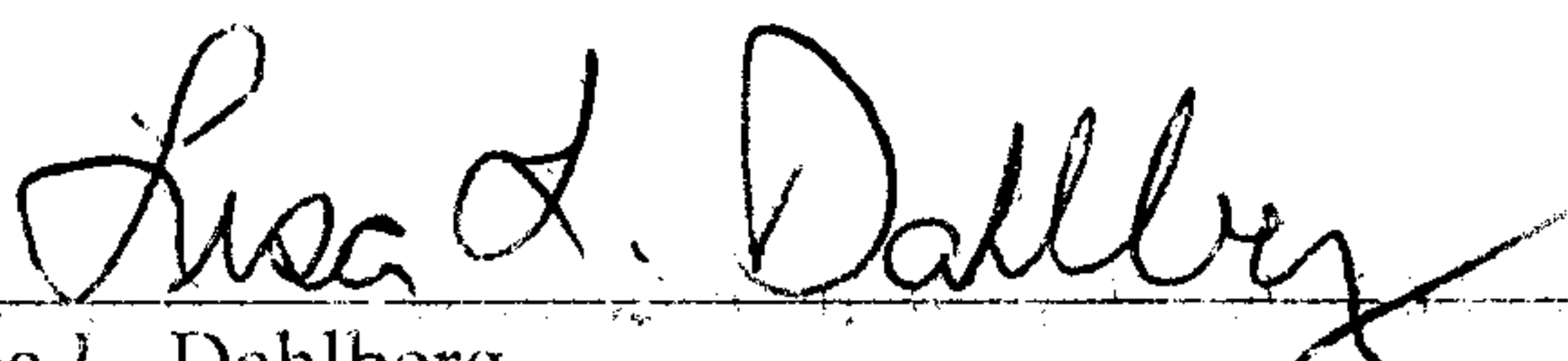
