Pursuant to Rule 18 IV., Rules of Judicial Administration, and §12-14-30(f), Ala. Code 1975, these persons should file their oaths in the "Office of the Secretary of State, with the Administrative Office of Courts" and with the clerk of the municipality," and, if their duties are limited to one county, they must also file with the judge of probate. See §36-4-4, Ala. Code 1975.
