

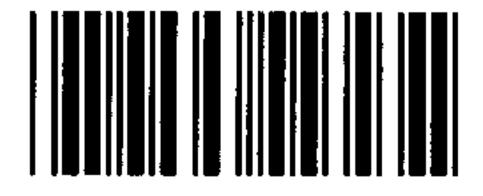

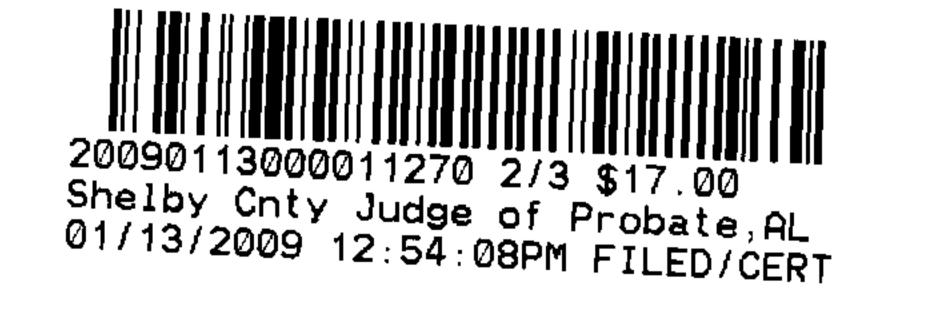

	Instrument upon the Property, as described above, and any and all advances made under or upon such loan or line of credit both before and after this date are hereby superior to the loan, lien and security instrument of New Lender. If SunTrust's Security Instrument secures a line of credit and the balance of that line of credit is reduced to zero (\$0.00) at any time, this insubordination shall remain in place and any subsequent advances shall be treated as superior to New Lender's loan and lien. New Lender also confirms that its new loan, dated or expected to be dated on or about is subordinate to and made subject to and is inferior to that certain lien upon the Property held by SunTrust.		
	SunTrust Bank confirms that its lien secured by the Property, as described above, and any and all advances made under this loan or line of credit after this date are hereby inferior and subordinate to the lien upon the property, created by the Security Instrument granted or given by Owner to New Lender up to the original principal balance of \$\frac{396,000.00}{1000}, for the purpose of refinancing the first lien on the Property.
