LIMITED POWER OF ATTORNEY

HSBC Bank USA a National Association, a national banking association (the "Company") as Indenture Trustee hereby irrevocably constitutes and appoints Chase Home Finance LLC(the "Servicer"), and its officers or agents thereof, with full power of substitution, as its true and lawful attorney-in-fact with full irrevocable power and authority in the place a stead of the Company and in the name of the Company or in its own name, from time to time in Servicer's discretion, for the purpose of servicing mortgage loans, related to that certain Transfer and Serving Agreements FBR Securitization Trust 2005-1, Callable Mortgage-Backed Notes, Series 2005-1, to take any and all appropriate action and to execute any and all documents and instruments which may be necessary or desirable to accomplish the purposes of servicing mortgage loans, and, without limiting the generality of the foregoing, the Company hereby gives each of Servicer the power and right, on behalf of the Company, without assent by the Company, to do the following, to the extent consistent with the terms and conditions of the Transfer and Servicing Agreements and Servicing Agreements for FBR Securitization Trust 2005-1, Callable Mortgage-Backed Notes, Series 2005-1

- to direct any party liable for any payment under any loans to make payment of any and all (A) moneys due or to become due thereunder directly to the Servicer or as the Servicer shall direct and in the name of the Company or its own name, or otherwise, to take possession of and endorse and collect any checks, drafts, notes, acceptances, or other instruments for the payment of moneys due under any loans (including those related to mortgage insurance); (B) to execute substitutions of trustee, assignment, reconveyance documents, foreclosure documents, modifications, subordinations, grant deeds and other instruments conveying real property, and such other documents as the Servicer deems necessary to carry out its obligations to service the mortgage loans; (C) to ask or demand for, collect, receive payment of and receipt for, any and all moneys, claims, and other amounts due or to become due at any time in respect of or arising out of any loans; (D) to commence and prosecute any suits, actions, or proceedings at law or in equity in any court of competent jurisdiction to collect the loans or any thereof and to enforce any other right in respect of any loans; and (E) generally, to do, at the Servicer's option, at any time, and from time to time, all acts and things which the Servicer, deems necessary to protect, preserve or realize upon the loans and the liens thereon and to effect the intent of the Agreement, all as fully and effectively as the Company might do.
- (B) The Company hereby ratifies all that said attorneys shall lawfully do or cause to be done by virtue hereof. This power of attorney is a power coupled with an interest and shall be irrevocable.
