KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 6th day of March, 2007, William D. Lott and wife, Lauren M. Lott, executed that certain mortgage on real property hereinafter described to Keesler Federal Credit Union, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20070312000109550, said mortgage having subsequently been transferred and assigned to PHH Mortgage Corporation, ("Transferee"); and
