KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 6th day of March, 2007, William D. Lott and wife, Lauren M. Lott, executed that certain mortgage on real property hereinafter described to Keesler Federal Credit Union , which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20070312000109550, said mortgage having subsequently been transferred and assigned to PHH Mortgage Corporation, ("Transferee"); and

WHEREAS, on January 16, 2009, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and PHH Mortgage Corporation did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and


