ORDER

THIS CAUSE coming on to be heard on Plaintiff Jenkins Brick Company's Application, Affidavit, and Entry of Default Judgment, and the Defendants J. Elliott Corp. and James W. Elliott having been served on January 4, 2008, but failing to appear or otherwise defend this action, upon the affidavit of the Plaintiff and for good cause being shown, it is therefore ORDERED, ADJUDGED, AND DECREED by the Court as follows:

- 1. That a money judgment is hereby entered in favor of the Plaintiff, Jenkins Brick Company, and against the Defendants, Defendants J. Elliott Corp. and James W. Elliott, in the amount of \$9,221.10, which said judgment is composed of \$7,514.97 in principal, \$578.91 in interest, and \$1,127.25 in attorney's fees, which are recoverable pursuant to the Contract entered into between Defendants, J. Elliott Corp. and James W. Elliott, and Plaintiff Jenkins Brick Company.
- 2.
