




Highway No. 17; thence run S 87°21'22" W for 149.97 feet; thence run S 02°32'45" E for 100.17 feet; thence run N 87°20'56" E for 150.21 feet to a point on the Westerly right-of-way line for Shelby County Highway No. 17; thence run S 02°40'56" E along said right-of-way line for 259.95 feet; thence run S 67°09'12" W along the North line of Block 3, according to the Survey of Shelena Estates Subdivision for 463.47 feet; thence run S 67°52'39" W along said subdivision for 96.21 feet; thence run S 82°43'02" W along said subdivision for 89.47 feet; thence run S 89°58'01" W along said subdivision for 50.00 feet; thence run N 00°00'00" E along said subdivision for 399.85 feet to the Point of Beginning.
