

SUBORDINATION AGREEMENT

Notice: This Subordination Agreement results in your security interest in the property becoming subject to and of lower priority than the lien of some other or later security instrument.

This Subordination Agreement made as of the 23 day of January, 2009, by Wachovia Bank, National Association (name of original lender), having an address of P.O. Box 50010 Roanoke, VA 24022 ("Subordinator"), and Wells Fargo Bank, N.A. (Name of New Lender), a corporation organized and existing under the laws of the State of Minnesota with its principal place of business at 2051 Killebrew Drive, Suite 500, Bloomington, MN 55425 ("Lender").

RECITALS:

- A. Samuel T. Walley and Loren Walley (Name of Borrower), of 112 Morning Mist Trail, Alabaster, AL 35007 (address), ("Borrower") has applied to Lender for a loan to be made to Borrower and to be evidenced by a promissory note secured by a mortgage covering certain real property.
