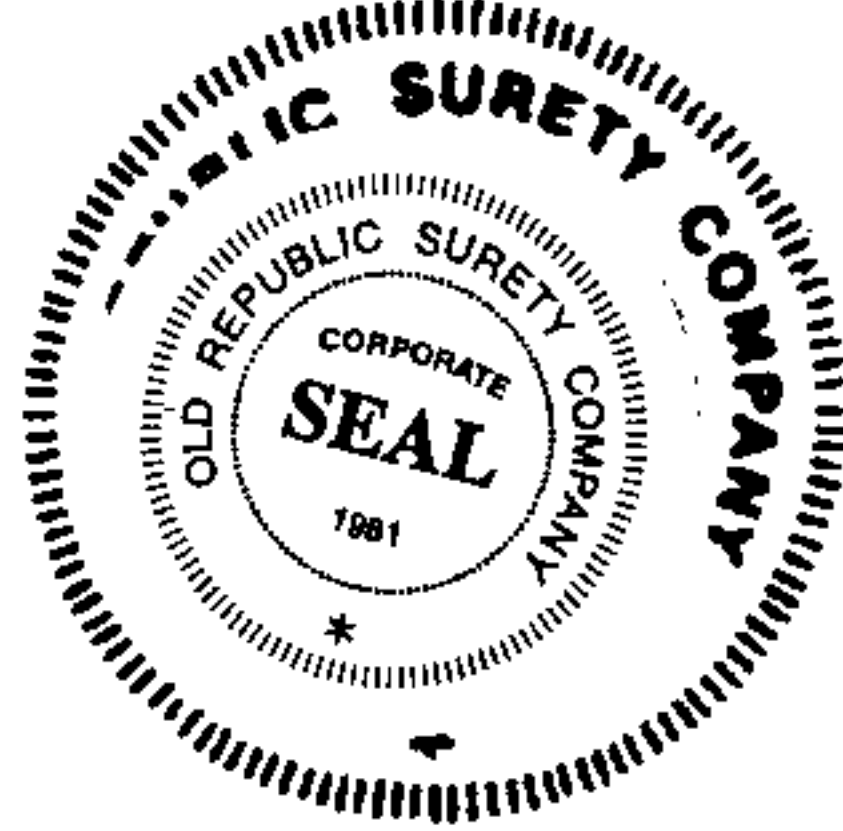

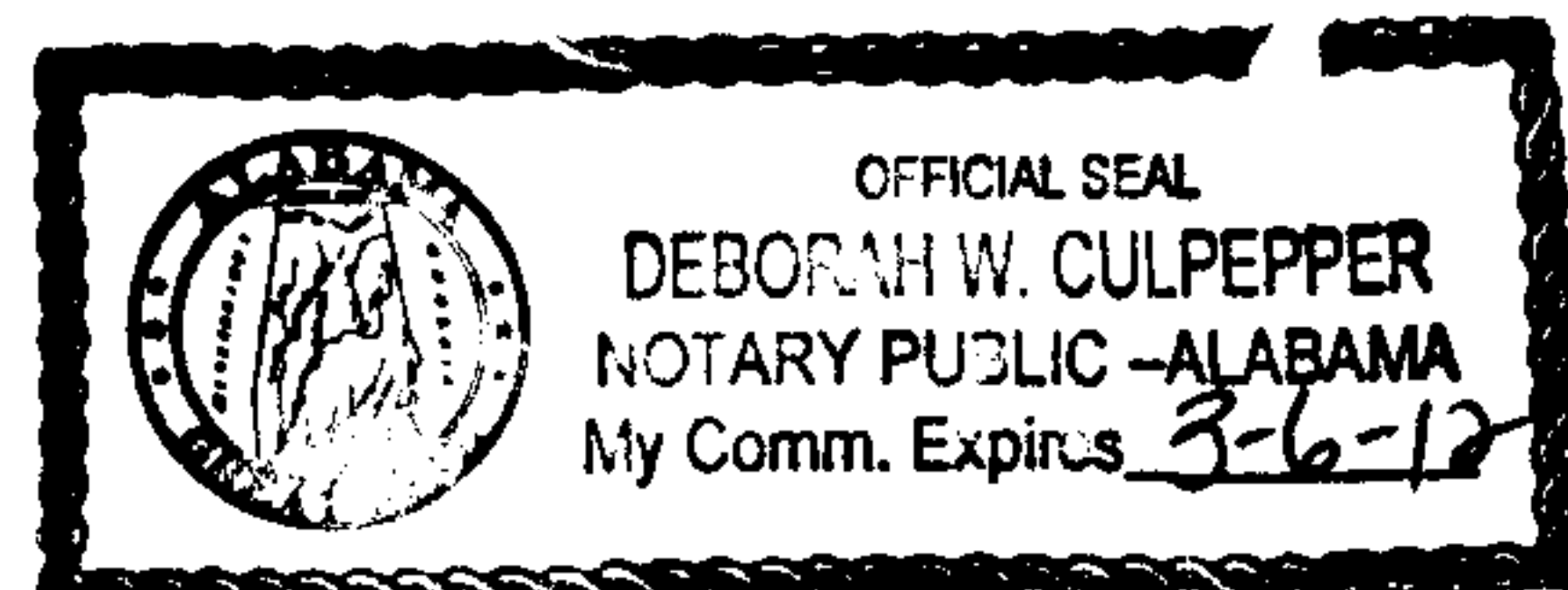

# POWER OF ATTORNEY
