

## WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS, That in consideration TEN THOUSAND AND NO/00 DOLLARS (\$10,000.00), and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, LANCE POSEY and wife, RHONDA A. POSEY (herein referred to as Grantor) grant, bargain, sell and convey unto LANCE POSEY and wife, RHONDA A. POSEY (herein referred to as Grantees), the following described real estate, situated in: SHELBY County, Alabama, to-wit:

Lot 6, according to the survey of THE WILLOWS, Phase One, as recorded in Map Book 27, Page 62, in the Probate Office of Shelby County, Alabama.

## SUBJECT TO:
