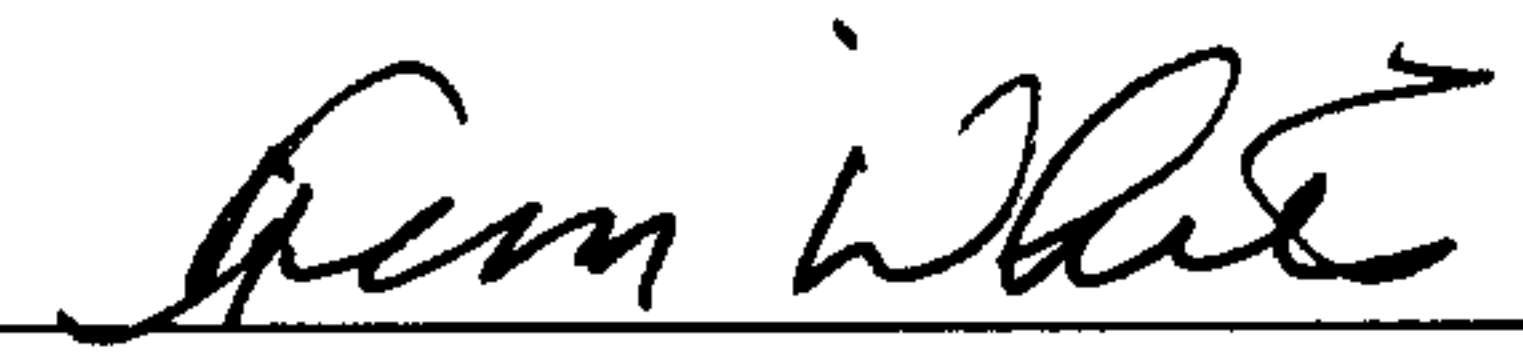

Article III All debts, obligations, and liabilities of the corporation have been paid and discharged or that adequate provisions have been made therefore, except as identified in Article V.

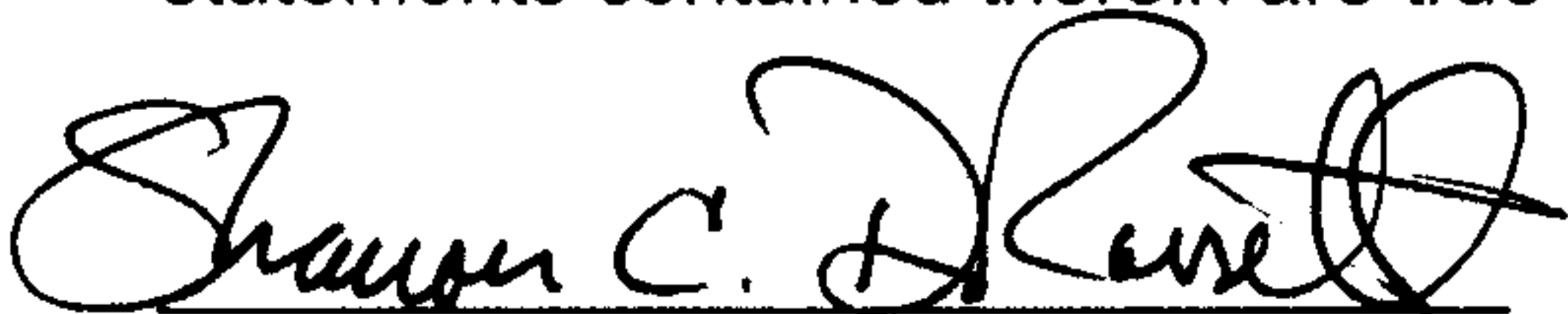

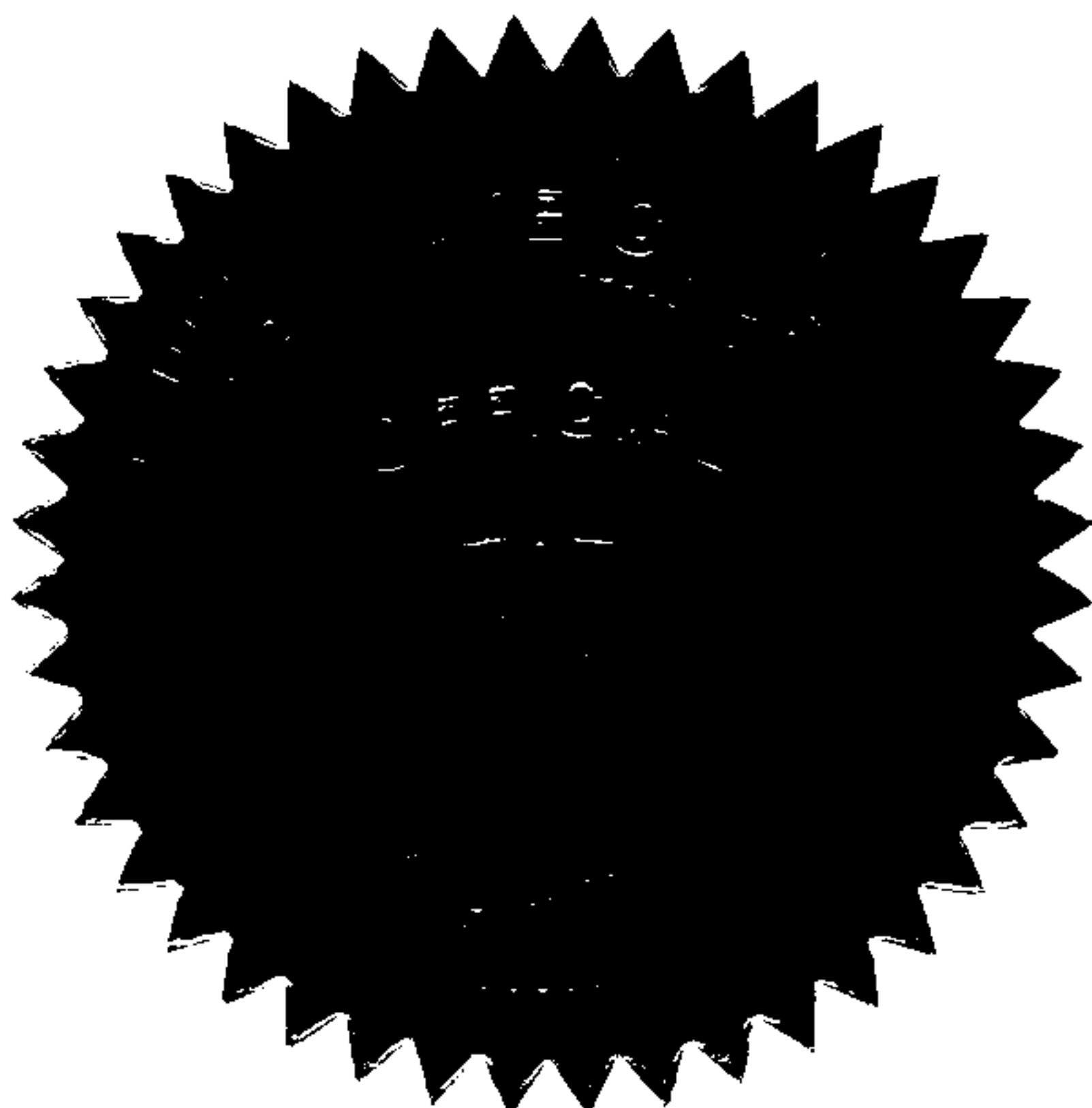
