Articles of Organization
Of
J & M Dental Solutions, L.L.C.

The undersigned, being all the members of J & M Dental Solutions, L.L.C., a limited liability company formed pursuant to section 10-12-1 et seg. of the Code of Alabama, adopts the following Articles of Organization for such company:

First: The name of the company is J & M Dental Solutions, L.L.C.

Second: The term of the company shall be perpetual from the date of the filing of these Article s of Organization in the office of the Judge of Probate of the county in which the initial registered office of the company is located, provided, however that the company shall be dissolved (A) upon the written consent of the holders of the portion of the ownership interest of the company specified in the Operating Agreement, as amended from time to time. (B) as provided in the Operating Agreement, as amended from time to time, or (C) as may be required by the Alabama Limited Liability Company Act.

Third: The purpose or purposes for which the company is organized are:

- (a) To manufacture, sell and repair ultrasonic scalers, polishers, water filters and other such functions dealing with the manufacturing of equipment, parts and supplies used in the veterinary dental industry; and
- (b) The transaction of any and all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act, including, but not limited to, any and all transactions which are necessary, appropriate or incidental to the acquisition, ownership, leasing, renting and selling of, and investment, in real property.

Fourth: The names and addresses of the initial members of the company are as follows:

Sixth: The company shall be managed by the following members who are to serve as managers until the first annual meeting of members or until their successors are elected and qualify:



Seventh: The initial members shall have no right to admit additional members except in accordance with Operating Agreement, as amended from time to time.

Eighth: Upon the dissociation of a member of the company or the occurrence of any other event which terminates the continued membership of a member in the company under the Alabama Limited Liability Company Act, the business of the company shall not be continued and the company shall be dissolved unless there are at least two remaining members of the company or at least one remaining member of the company and additional member is admitted to the company in accordance with these Article of Organization and the Operating Agreement of the company, and there is thereafter obtained the written consent of all the then remaining and existing members of the company within ninety (90) days after the occurrence of such terminating event.

Ninth: All other provisions for the regulation of the internal affairs of the company shall be set out in the Operating Agreement, as amended from time to time and shall be in compliance with Alabama Limited Liability Company Act.
