KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of May, 2004, Lou Anne Jones, single person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as a nominee for RBMG, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20040628000352280, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A, by instrument \* 20090223000064840 recorded in the aforesaid Probate Office ("Transferee"); and


