Subordination Agreement

THIS AGREEMENT is made and entered into on this 12 day of February 2009, by Regions Bank (hereinafter referred to as "Regions") in favor of SUPERIOR BANK, its successors and assigns (hereinafter referred to as "Lender").

RECITALS

Regions loaned to GREGORY L. TUCKER (the "Borrower") whether one or more) the sum of \$330,000.00. By its acceptance of this agreement, the Borrower agrees to pay the Subordination Fee set out in the Regions Subordination Request Form.
