WHEREAS, heretofore, on, to-wit: the 1st day of March, 2006, Betty Johnson and David Johnson, Wife and Husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Mortgage Lenders Network USA, Inc.
