CERTIFICATE OF JUDGMENT

I, **Sharon Harris**, Clerk of the United States District Court for the Northern District of Alabama, do hereby certify that a Final Judgment By Default was rendered by the United States District Court for the Northern District of Texas, Dallas Division on the 28th day of October, 2008 and registered in the United States District Court for the Northern District of Alabama on the 20th day of February, 2009, in the above-styled cause wherein: Plaintiff Monitronics obtained a Judgment against Defendant Security First for breach of contract damages in the amount of \$201,026.08 Dollars, with pre-judgment interest on that amount through October 28, 2008, in the amount of \$7,322.98, with additional pre-judgment interest accruing thereafter at the rate of \$27.53 per day from October 29, 2008 through the date of judgment. Further that Plaintiff Monitronics, obtained a judgment against Defendants Security First and Baguer, jointly and severally, actual damages for fraud in the amount of \$9,443.20 Dollars, with pre-judgment interest on that amount through October 28, 2008 in the amount of \$343.14, with additional pre-judgment interest accruing thereafter at the rate of \$1.29 per day from October 29, 2008 through the date of Judgment. Further that Plaintiff Monitronics obtained judgment against Defendants Security First and Baguer, jointly and severally, for exemplary damages in an amount equal to two times the actual fraud damages awarded to Plaintiff, in the amount of \$18,886.40. Further that Plaintiff Monitronics obtained sanctions against Defendant Baguer, awarding Monitronics' attorneys fees and costs in the amount of \$10,119.42. Further awarding Plaintiff Monitronics attorneys' fees in the amount of \$49,479.75, and in the additional sum of \$25,000.00 as a reasonable attorneys' fee in connection with any unsuccessful appeal by Defendant Security First related to the entry of this Final Judgment By Default to the Fifth Circuit Court of Appeals. Further that all sums awarded herein, including court costs, shall bear interest in favor of the person to whom such sums are due at the rate of 1.25% per annum from the date of judgment until paid; costs awarded against Defendants, Security First and Baguer, jointly and severally in the amount of \$647.75; the Defendants' address, as shown in court proceedings in the action resulting in the judgment, is 4068 Crossings Lane, Birmingham, Alabama 35242; and that Marc S. Culp, Benjamin S. Dyer, Angela J. Hindman, and Margaret J. Carlson, all of Culp, Dyer & Halpern, LLP, 222 E. McKinney, Suite 210 Denton, Texas 76201 are the Attorneys of Record for Plaintiff in said cause.
