

**SUBORDINATION AGREEMENT**

This Subordination of Mortgage is executed this 6<sup>th</sup> day of February, 2009 by Wachovia Bank, National Association FKA SouthTrust Bank of Alabama, N.A.

**WITNESSETH**

WHEREAS, Wachovia Bank, National Association is the owner and holder of that certain mortgage from JACK F. SHAW and ALLISON A. **THE WEST 1/2 OF SOUTHWEST 1/4 OF SOUTHWEST 1/4 AND THE NORTH 1/2 OF NORTHEAST 1/4 OF SOUTHWEST 1/4 OF SOUTHWEST 1/4 OF SECTION 12, TOWNSHIP 20 SOUTH, RANGE 2 WEST, SHELBY COUNTY, ALABAMA.**

**ALSO, A TWENTY FOOT (20) WIDE EASEMENT DESCRIBED AS FOLLOWS: COMMENCE AT THE SOUTHEAST CORNER OF THE NORTHEAST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 12, TOWNSHIP 20 SOUTH, RANGE 2 WEST, SHELBY COUNTY, ALABAMA, AND RUN THENCE WESTERLY ALONG THE SOUTH LINE OF SAID 1/4-1/4 SECTION A DISTANCE OF 182.55 FEET TO A POINT ON THE WESTERLY RIGHT OF WAY LINE OF A PAVED SHELBY COUNTY PUBLIC ROAD AND THE POINT OF BEGINNING OF THE EASEMENT BEING DESCRIBED; THENCE CONTINUE ALONG LAST DESCRIBED COURSE A DISTANCE OF 1,159.53 FEET TO A POINT TWENTY FEET (20) WEST OF THE SOUTHWEST CORNER OF THE NORTHEAST 1/4 OF THE SOUTHWEST 1/4 OF SAID SECTION 12 AND ON THE SOUTH LINE OF THE NORTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SAME SAID SECTION 12; THENCE TURN A DEFLECTION ANGLE OF 90 DEGREES 00 MINUTES 00 SECONDS RIGHT AND RUN NORTHERLY A DISTANCE OF 20.00 FEET TO A POINT; THENCE TURN A DEFLECTION ANGLE OF 90 DEGREES 00 MINUTES 00 SECONDS RIGHT AND RUN EASTERLY PARALLEL WITH THE SAID SOUTH LINE OF SAID NORTHWEST 1/4 OF THE SOUTHWEST 1/4 AND THE NORTHEAST 1/4 OF THE SOUTHWEST 1/4 OF SAID SECTION 12 A DISTANCE OF 1,140.54 FEET TO A POINT ON THE SAME SAID WESTERLY RIGHT OF WAY LINE OF SAME SAID SHELBY COUNTY PUBLIC ROAD; THENCE TURN A DEFLECTION ANGLE A DISTANCE OF 46 DEGREES 28 MINUTES 31 SECONDS RIGHT AND RUN SOUTHEASTERLY ALONG SAID RIGHT OF WAY LINE OF SAID PUBLIC ROAD A DISTANCE OF 27.58 FEET TO THE POINT OF BEGINNING; BEING SITUATED IN SHELBY COUNTY, ALABAMA.**
