

SPECIAL POWER OF ATTORNEY

THIS IS A MILITARY POWER OF ATTORNEY PREPARED AND EXECUTED PURSUANT TO TITLE 10, UNITED STATES CODE, SECTION 1044B, BY A PERSON AUTHORIZED TO RECEIVE LEGAL ASSISTANCE FROM THE MILITARY SERVICES. FEDERAL LAW EXEMPTS A MILITARY POWER OF ATTORNEY FROM ANY REQUIREMENT OF FORM, SUBSTANCE, FORMALITY OR RECORDING THAT IS PROVIDED FOR POWERS OF ATTORNEY BY THE LAW OF ANY STATE, COMMONWEALTH, TERRITORY, DISTRICT, OR POSSESSION OF THE UNITED STATES. FEDERAL LAW SPECIFIES THAT A MILITARY POWER OF ATTORNEY SHALL BE GIVEN THE SAME LEGAL EFFECT AS A POWER OF ATTORNEY PREPARED AND EXECUTED IN ACCORDANCE WITH THE LAWS OF THE JURISDICTION WHERE IT IS PRESENTED.

KNOW ALL PERSONS, that I, Jared Lee Pierce, a legal resident of Alabama, and presently serving and residing at Baghdad, Iraq, desiring to execute a SPECIAL POWER OF ATTORNEY, do hereby appoint Angela Leslie Ann Pierce, who resides at 136 Kensington Manor Dr, Calera, AL 35040, as my Attorney-in-Fact to act as follows, GRANTING unto my said Attorney full power to:

- a. To purchase in my name and for my use the below-described residential property at 2000 Kensington Court, Calera, AL 35040, and for that purpose to make, indorse, accept, receive, sign, seal, execute, acknowledge, and deliver any application forms, documents, instruments, or paper necessary or convenient to enter into both a contract and mortgage or deed of trust upon said real estate for such price, at such rate of interest and upon such terms as she shall deem best.
- b. To secure, purchase, finance, insure and complete all documents necessary thereto, for me and in my name, and on such terms as my said Attorney-In-Fact shall think best. My Attorney-in-Fact is hereby empowered to sign my name and execute on my behalf all deeds, instruments and other documents incident thereto which may be necessary or proper to complete this transaction.

TERMINATION: This Power of Attorney shall become null and void the 22nd day of May, 2009, unless I should become incapacitated; in that case, it shall remain in effect until revoked by me.
