KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of August, 2007, Bradley B. Allred, a married person and Elizabeth Allred, married (husband and wife), executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for BSM Financial, L.P. d/b/a Brokersource, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20070821000394940, said mortgage having subsequently been transferred and assigned to MidFirst Bank, by instrument recorded in the aforesaid Probate Office ("Transferee"); and

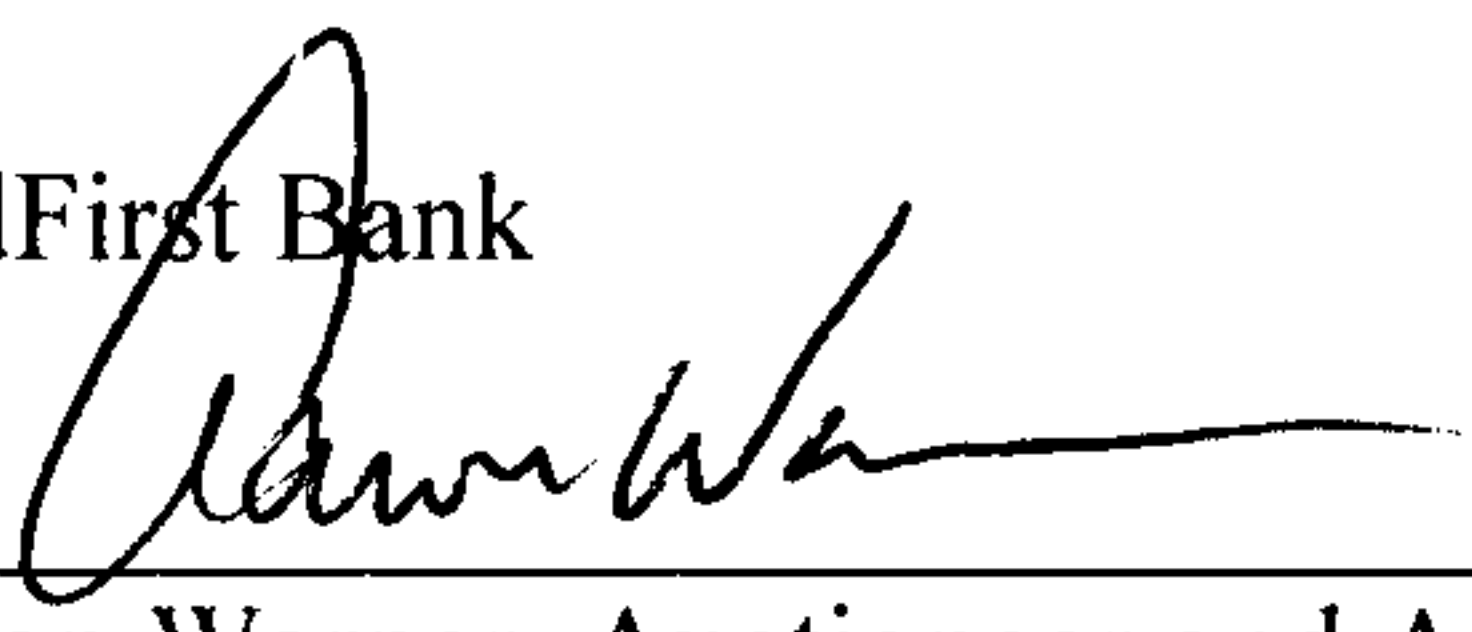

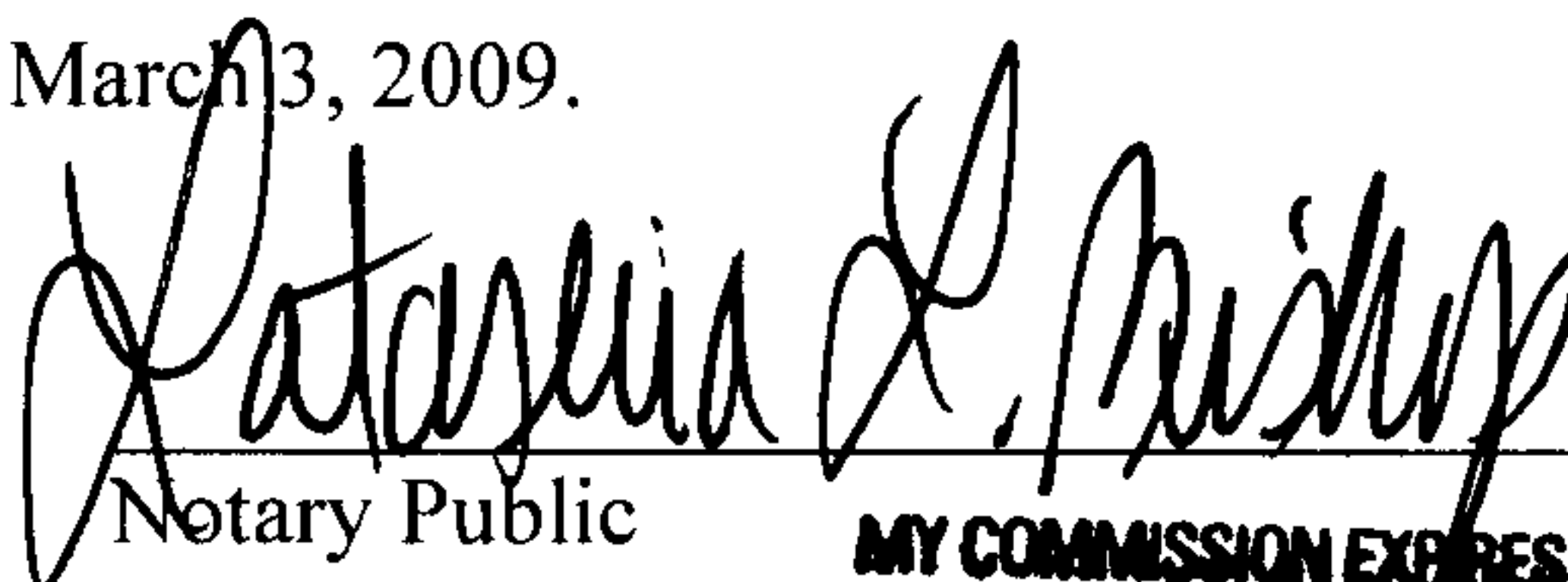
