FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 9th day of November, 2005, Jimmy Odum, unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Southstar Funding, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20051114000594200, said mortgage having subsequently been transferred and assigned to U.S. Bank National Association as trustee for RASC 2006-KS3, ("Transferee"); and
