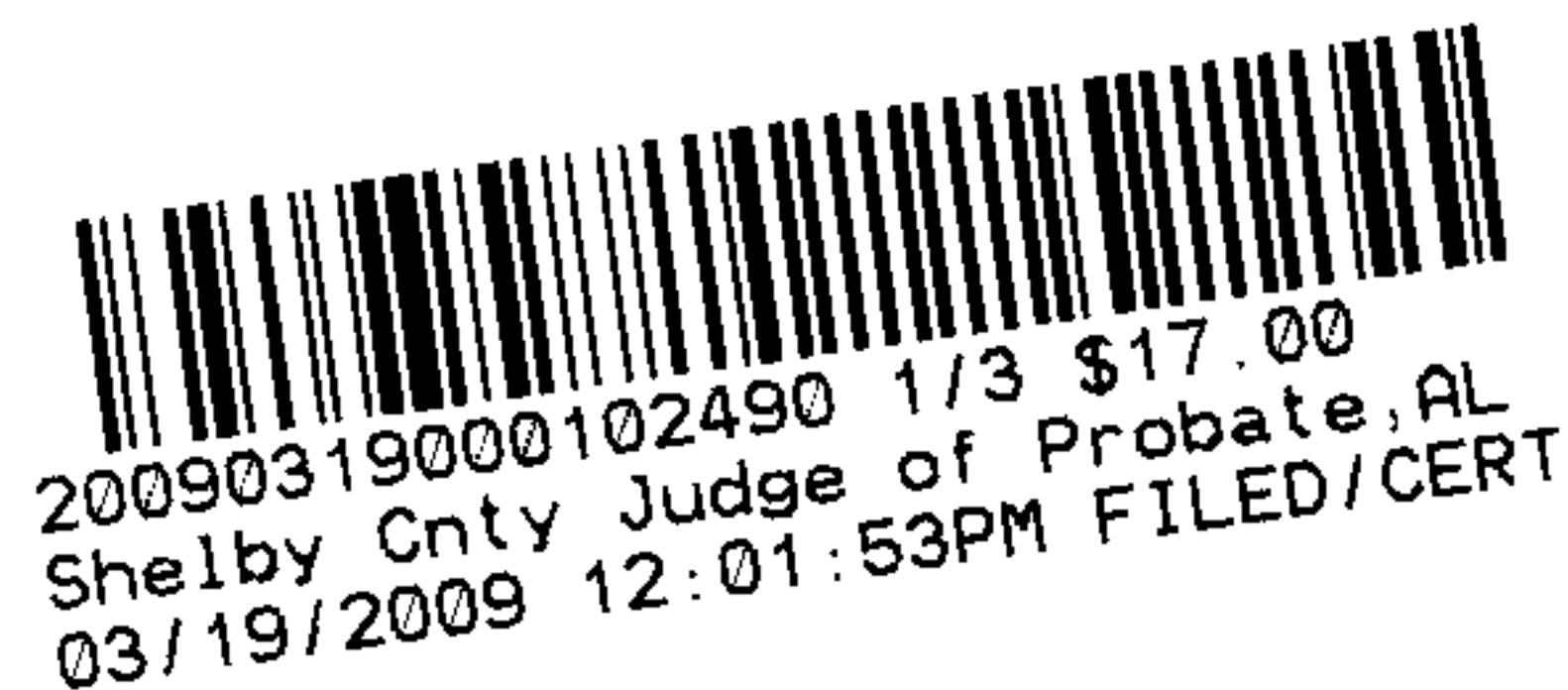

## LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, THAT Countrywide Home Loans, Inc., a corporation organized under the laws of the State of New York, ("Principal"), has made, constituted and appointed, and by these presents does make, constitute and appoint, Jerry E. Held, Stephen G. Collins and Ginny C. Rutledge of the firm of Sirote & Permutt, P.C., 2311 Highland Avenue South, Birmingham, Alabama 35205, as its attorney-in-fact ("Attorney-in-Fact") to act with the following limited powers, to wit:

*Execution on behalf of Principal of the following document or documents:*

Nothing contained in this Limited Power of Attorney shall be construed or interpreted to relieve the Attorney-in-Fact from a proper accounting of their actions to Countrywide Home Loans, Inc. and its successors and assigns, but persons dealing with the Attorney-in-Fact shall be under no duty to see that this is done.
