KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Two Hundred Seventy Seven Thousand dollars and Zero cents ( \$277,000.00 ) paid by the grantee herein, \* the receipt of which is hereby acknowledged, I/we, **Margaret Pearson and Martin L. Pearson** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Jeffrey D. Glover and Candice R. Glover as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama:** **\*as husband and wife**
