

CONSENT TO VACATION

This Consent to Vacation is entered into as of the <u>26</u> day of March, 2009.

WHEREAS, TP DEVELOPMENT COMPANY, LLC ("TP") and SAUNDERS BRIDGE HOMEOWNERS ASSOCIATION, INC. ("SBHA") currently either own or control property on which Twin Pines Road, a public road, was previously located in the South half of Section 23 and in Section 26 Township 18 South Range 1 East Shelby County, Alabama (the "Area");

WHEREAS, Leroux Entertainment Corporation of America ("Leroux"), TP's predecessor in title, purportedly vacated that part of Twin Pines Road that crossed its property;

WHEREAS, Leroux requested that the Shelby County Commission approve the vacation of said portion of Twin Pines Road in the Area, which request was approved by Resolution 00-08-28-08 of the Shelby County Commission (the "Vacation"); and

WHEREAS, The undersigned did not receive notice of such vacation.

NOW, THEREFORE, for One Dollar (\$1.00) and other good and valuable consideration, the undersigned:

- 1. consent to the Vacation of that part of Twin Pines Road located in the Area;
- waive any rights that they may have to contest or object to the Vacation or otherwise use that portion of Twin Pines Road purportedly vacated;
- acknowledge that the portion of Twin Pines Road purportedly vacated is currently part of a private development, and not subject to use by the public;
- 4. affirmatively state that other access is and has been provided for ingress and egress to their respective properties;
- agree that they will not contest the methods or procedures of the previous vacation efforts by Leroux;
- 6. agree that the actions of Leroux and the Shelby County Commission in vacating that portion of Twin Pines Road in the Area are binding on them and the heirs, successors and assigns of property currently owned by them; and
- 7. acknowledge and assert that the part of Twin Pines Road that lies northeast of the Saunders Bridge Subdivision, 1st Sector as recorded in Map Book 38, Page 38A-38D, in the Probate Office of Shelby County, Alabama is and remains a public road, was not affected by the previous Vacation, and is not a part of the vacation referenced in this Consent to Vacation.

This Consent to Vacation may be signed in multiple counterparts, but each such counterpart shall constitute but one original.

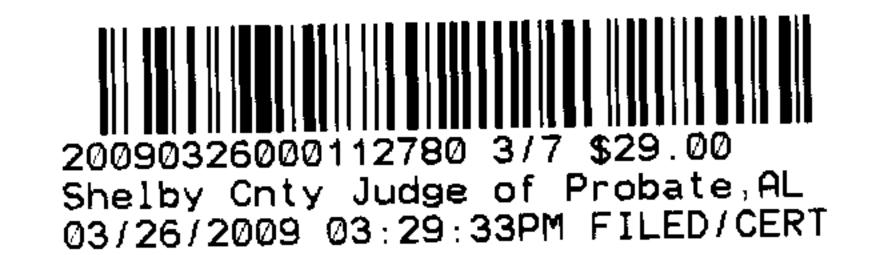

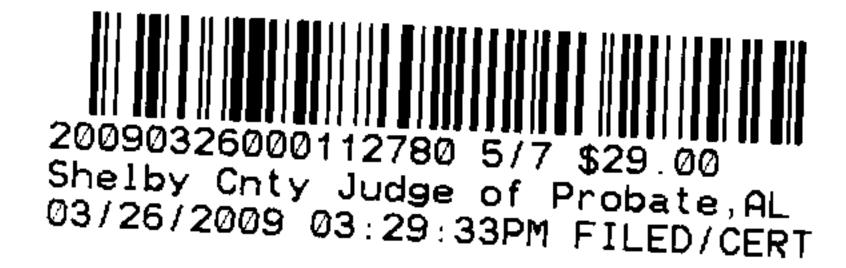

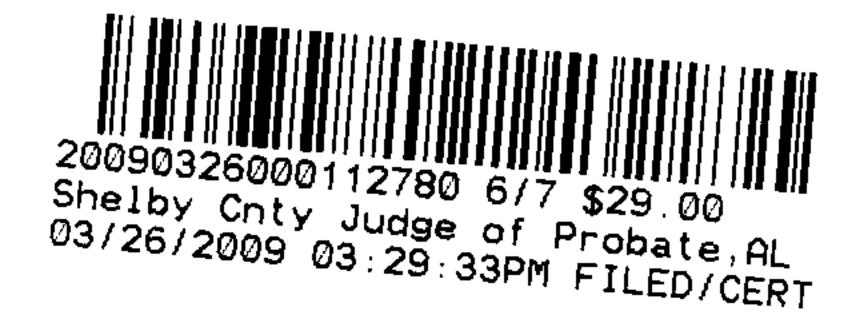
