ORDER GRANTING
PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT

First Commercial Bank (the "Plaintiff" or "First Commercial") filed a Motion for Summary Judgment (the "Motion") in this Court on the 10th day of July, 2008. In its Motion, the Plaintiff requested that summary judgment be entered against Bill Brantley and Rhonda Brantley (the "Defendants") for money damages in the principal amount of \$260,880.13, plus interest of \$62,534.57, late fees of \$5,888.35, other fees of \$12,290.37, and attorney's fees of \$68,318.68, for a total of \$409,912.10, plus court costs.

The Court has reviewed the Motion and finds that it is due to be granted; therefore, IT IS ORDERED that the Motion for Summary Judgment filed by the Plaintiff, First Commercial Bank, against the Defendants, Bill Brantley and Rhonda Brantley, is GRANTED and JUDGMENT is entered in favor of the Plaintiff and against the Defendants for money damages in the principal amount of \$260,880.13, plus interest of \$62,534.57, late fees of \$5,888.35, other fees of \$12,290.37, and attorney's fees of \$68,318.68, for a total of \$409,912.10, plus court costs.
