WHEREAS, the County Commission has referred this application to the Shelby County Health Department for investigation; and


WHEREAS, the Shelby County Health Department has made the investigation and recommends approval as per letter dated March 25, 2009.

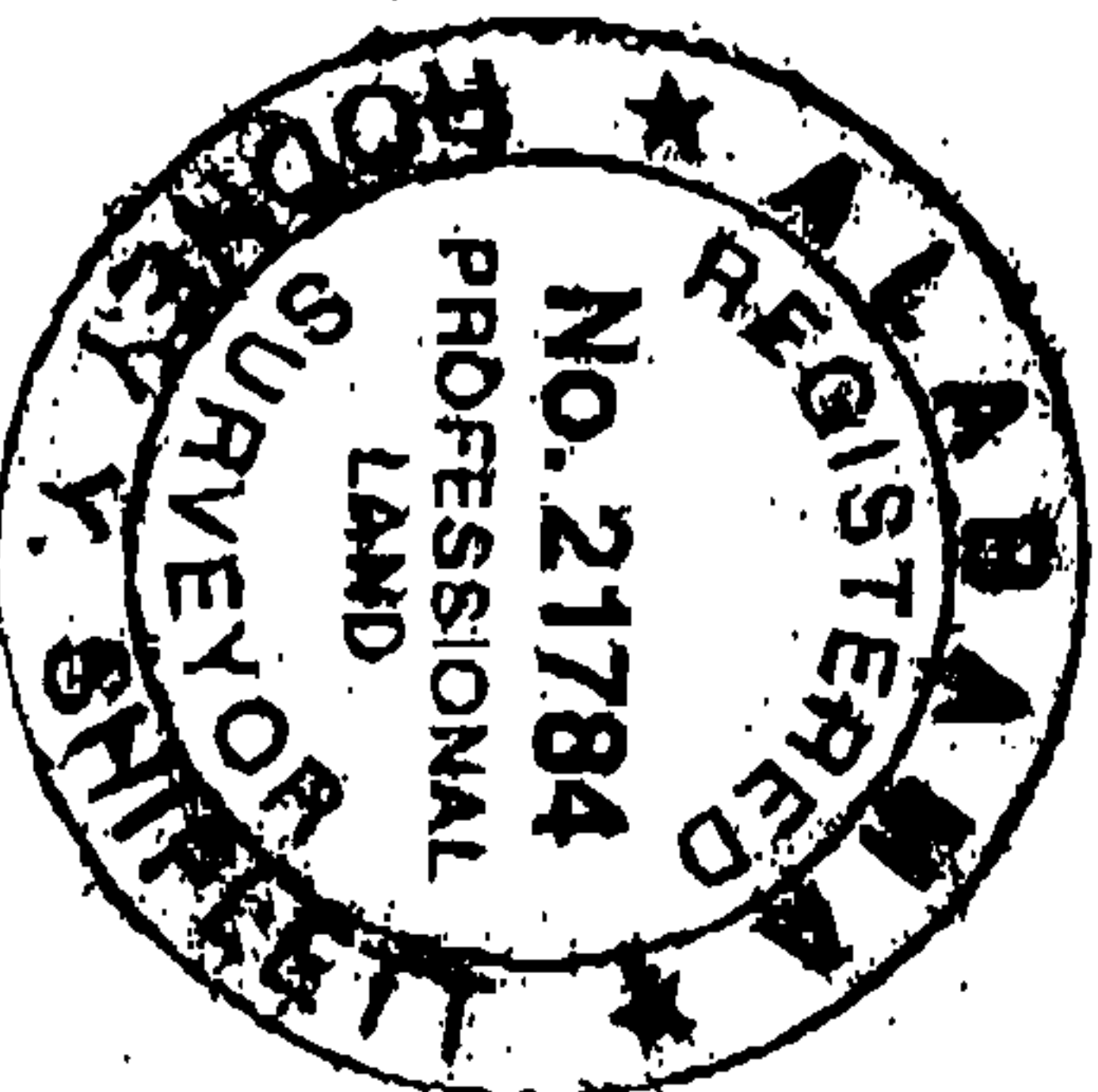
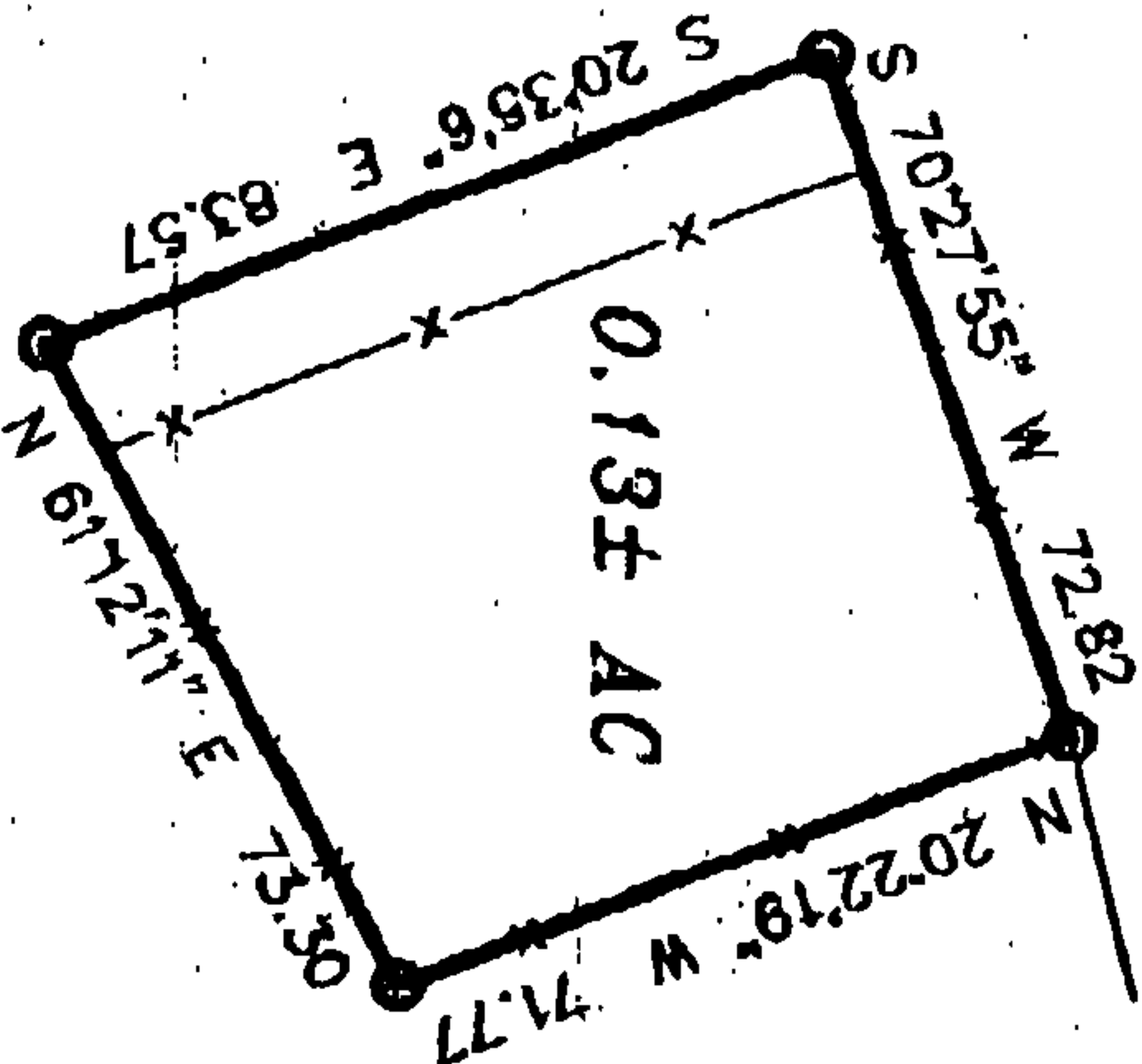
