SUBORDINATION AGREEMENT

This Subordination Agreement made as of the 24TH day of JULY, 2006, by WACHOVIA BANK NA (herein "Subordinating Lender") and WACHOVIA BANK NA, a national banking association (herein "Lender").

WHEREAS:

- A. PATRICIA LEE BURDETT, of 8389 HWY 11, CHELSEA, ALABAMA, 35043-9009 (herein "Borrower"), has applied to Lender for a loan in the amount of \$34,767.20 to be made to Statement. Such debt will be secured by a security instrument covering certain real property recorded on or shortly thereafter JULY 24, 2006 (herein "Subsequent Security Instrument").

- NOW, THEREFORE, for a good and valuable consideration, the receipt of which is hereby acknowledged, Subordinating Lender hereby agrees that the lien of the Original Security Instrument is subordinate and junior to the lien of the Subsequent Security Instrument including any modifications, extension or renewal of the Subsequent Security Instrument and that the Subsequent Security Instrument shall also have a prior and superior right over the lien of the Original Security Instrument.
