\$239,900.00 of the Consideration was paid from the proceeds of a mortgage loan.

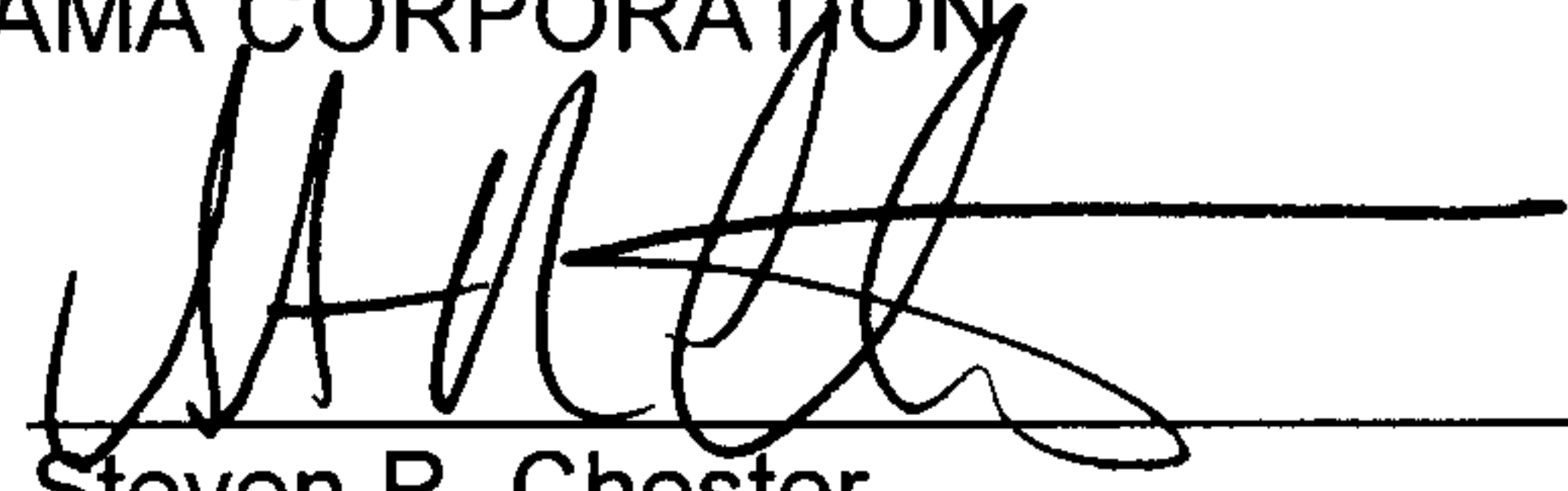

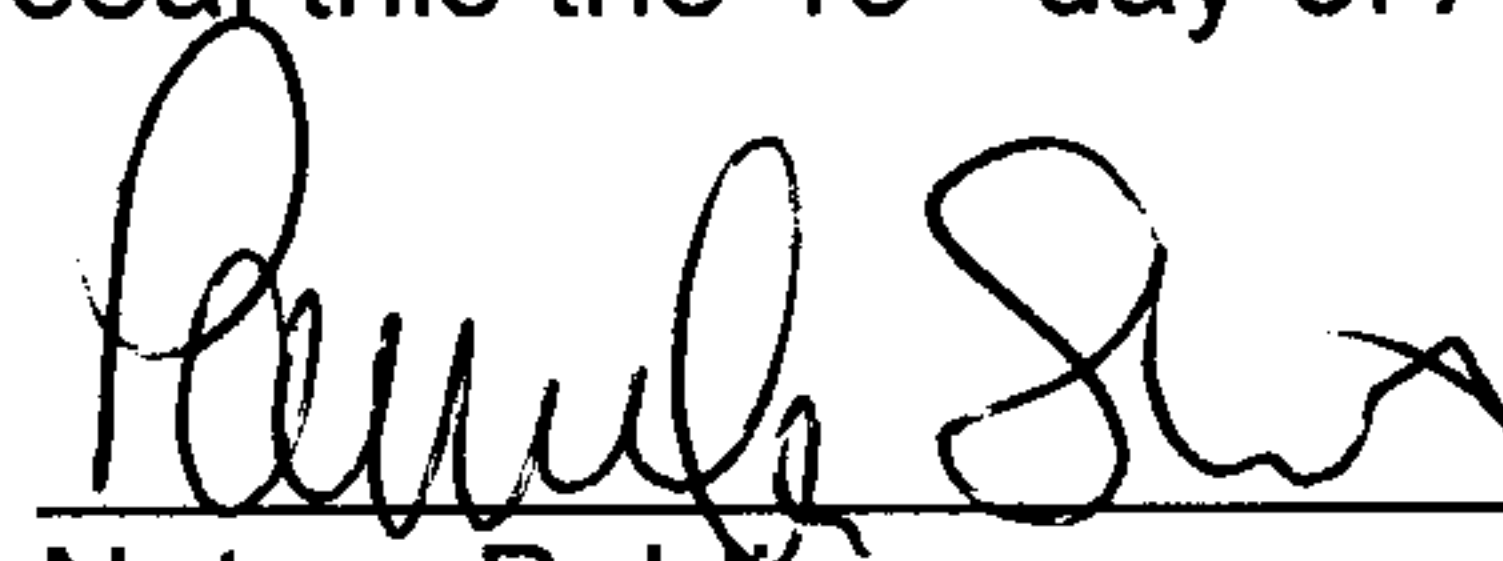
