

ARTICLES OF ORGANIZATION

OF

ALSTATE SECURITY, LLC

Pursuant to the provisions of Act No 93-724 of the 1993 Alabama Legislature, as amended, the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I

THE NAME OF THE LIMITED LIABILITY COMPANY IS:

ALSTATE SECURITY, LLC

ARTICLE II

DURATION


The existence of the Limited Liability Company shall commence on the date of the filing of the Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue in perpetuity, or until the Limited Liability Company shall be dissolved prior to such date (a) upon the written consent of the Members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.

ARTICLE III

PURPOSE

The Limited Liability Company has been organized for the following purposes:

- (a) To sell, install and service home and business security systems in the State of Alabama.
- (b) To acquire, purchase, own, hold, operate, develop, lease, mortgage, pledge, exchange, sell, transfer or otherwise dispose of and to invest in, trade or deal in, real or personal property of every kind and description or any interest therein.
- (c) To enter into, make and perform contracts and agreements of every kind for every lawful purpose with any person, firm, corporation, municipality or political body, whether related to the above described businesses or not.



- (d) To do all things necessary, suitable and proper for the accomplishments of any of the purposes or attainment of any of the objects, or the furtherance of any of the powers herein above set forth, either alone or in association of other corporations, firms, limited liability companies, or individuals, and to do every other act or acts, thing or things, incidental or appurtenant to, or growing out of, or connected with the aforesaid business or powers of any part or parts thereof, providing the same is not inconsistent with the laws under which this limited liability company is organized.
- (e) The limited liability company is organized for the purpose of conducting any or all lawful businesses allowed under the Alabama Limited Liability Company Act, Act No 93-724 of the Alabama Legislature, as amended.

The foregoing clauses shall be construed as purposes and powers and nothing herein shall be deemed to limit or exclude in any manner any right, power or privilege given to the Limited Liability Company by law or the authority which it is or might be permitted to exercise under the laws of the State of Alabama.

ARTICLE IV



OWNERSHIP

Jaclyn D. West Lolley shall have one hundred percent (100%) of the ownership of the Limited Liability Company, and any profit from the operation thereof shall be distributed in accordance with these percentages of ownership.

The Members of the Limited Liability Company shall have the right to admit additional Members to the Limited Liability Company upon the unanimous written consent of all the Members of the Limited Liability Company.
