Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature, the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I

THE NAME OF THE LIMITED LIABILITY COMPANY IS:

Garlington Group, L.L.C.

ARTICLE II

DURATION

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act, or other applicable laws.

ARTICLE III

PURPOSES

The Limited Liability Company has been organized for the following purposes:

The purpose is to engage in the business of investment in real estate. To that end the Company shall possess all the powers necessary to conduct a business and to carry out the objects expressed herein, together with all of those powers expressly conferred upon Limited Liability Companies or enumerated in Title 10 of the Code of Alabama, 1975, as last amended. The Organization shall also have all powers bestowed upon Limited Liability Companies under any of the laws of the State of Alabama, as well as those necessarily implied.

ARTICLE IV

REGISTERED AGENT/OFFICE

ADDITION OF MEMBERS


The initial Members of the Company may admit additional Members at such times and upon such terms and conditions as may be agreed by the Company and the additional Members.


ARTICLE VIII
