LIMITED POWER OF ATTORNEY

This Limited Power of Attorney is made in connection with those servicing agreements listed on "Exhibit A" attached hereto (the "Servicing Agreements"), by and between DLI Mortgage Capital, Inc., (hereinafter called "Owner") and Ocwen Loan Servicing, LLC (hereinafter called "Ocwen"),

- To execute, acknowledge, seal and deliver deed of trust/mortgage note endorsements, lost note affidavits, assignments of deed of trust/mortgage and other recorded documents, satisfactions/releases/reconveyances of deed of trust/mortgage, subordinations and modifications, tax authority notifications and declarations, deeds, bills of sale, and other instruments of sale, conveyance, and transfer, appropriately completed, with all ordinary or necessary endorsements, acknowledgments, affidavits, and supporting documents as may be necessary or appropriate to effect its execution, delivery, conveyance, recordation or filing.
- 2) To execute and deliver insurance filings and claims, affidavits of debt, substitutions of Owner, substitutions of counsel, non-military affidavits, notices of recission, foreclosure deeds, transfer tax affidavits, affidavits of merit, verifications of complaints, notices to quit, bankruptcy declarations for the purpose of filing motions to lift stays, and other documents or notice filings on behalf of Owner in connection with insurance, foreclosure, bankruptcy and eviction actions.
- 3) To endorse any checks or other instruments received by Ocwen and made payable to Owner.
- 4) To pursue any deficiency, debt or other obligation, secured or unsecured, including but not limited to those arising from foreclosure or other sale, promissory note or check, or related to any claim arising therefrom. This power also authorizes Ocwen to collect, negotiate or otherwise settle any deficiency claim, including interest and attorney's fees.
- 5) To do any other act or complete any other document that arises in the normal course of servicing as limited by the terms of the Servicing Agreements.

Nothing herein shall give any attorney-in-fact the rights or powers to negotiate or settle any suit, counterclaim or action against the Owner. The Owner will not be responsible for inspection of any items being executed pursuant to this Limited Power of Attorney and as such, is relying upon Ocwen to undertake whatever procedures may be necessary to confirm the accuracy of such items.

Any third party may rely upon a copy of this Limited Power of Attorney, to the same extent as if it were an original, and shall be entitled to rely on a writing signed by Ocwen to establish conclusively the identity of a particular right, power, capacity, asset, liability, obligation, property, loan or commitment of Ocwen for all purposes of this Limited Power of Attorney.

The Owner authorizes Ocwen, by and through any of its directors or officers, or any other employee who is duly authorized by Ocwen to certify, deliver and/or record copies and originals of this Limited Power of Attorney.

If any provision of this Limited Power of Attorney shall be held invalid, illegal or unenforceable, the validity, legality or enforceability of the other provisions hereof shall not be affected thereby.
