

# ARTICLES OF ORGANIZATION FOR LAW OFFICE OF ANN MARIE PUCCIO, LLC

The undersigned organizer, intending to organize a limited liability company under the Alabama Limited Liability Company Act, Title 10, Chapter 12, Code of Alabama (1975), as the same may be amended from time to time (the "Act"), hereby adopts the following Articles of Organization:

# ARTICLE I

# **NAME**

The name of the limited liability company shall be Law Office of Ann Marie Puccio, LLC (the "Company") and the address of the principal place of business of the limited liability company is 429 Bentmoor Way, Helena, AL 35080

# ARTICLE II

### **DURATION**

The duration of the company is perpetual.

# ARTICLE III

#### **PURPOSE**

The limited liability company has been organized in order to engage in the practice of law; and for transacting any other lawful act or activity for which limited liability companies may be organized pursuant to the Act under Alabama law.

# ARTICLE VI

#### **MANAGEMENT**

The management of the limited liability company shall be by one or more managers elected by the members from time to time, according to the terms, qualifications and procedures set forth in the Operating Agreement. Subject to any provisions in the Operating Agreement, if any, of the limited liability company, or the provisions of the Act, restricting or enlarging the management rights and duties of any person or group or class of persons, the managers shall have the right and authority to manage the business or affairs of the limited liability company and to make all decisions with respect thereto.

# ARTICLE VII

# DEATH, RETIREMENT, ETC. OF MEMBER

The limited liability company shall not end upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of any member or upon the occurrence of any other event which terminated the continued membership of a member unless the Operating Agreement, if any, expresses otherwise.

# ARTICLE VIII

#### **ADDITIONAL MEMBERS**

The members of the Company shall have the right to admit additional members to the Company in accordance with the terms of the Operating Agreement, if any, of the Company. If the Company does not have an Operating Agreement that provides for the admission of additional members, additional members may be admitted with the written consent of all the members at such time and upon such terms and conditions as may be mutually agreed upon by all the members and the person desiring to become a member.
