KNOW ALL MEN BY THESE PRESENTS, That,

WHEREAS, RCJ Home Building, Inc. (the "Grantor" or "RCJ") executed that certain Construction Mortgage to Regions Bank (the "Grantee" or "Regions"), dated February 13, 2006, and recorded in the Office of the Judge of Probate for Shelby County, Alabama, in Instrument No. 20060215000075200 (the "Mortgage"); and,

WHEREAS, default was made in payment of the indebtedness secured by said Mortgage, and Regions did declare all indebtedness secured by said Mortgage due and payable, and said Mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said Mortgage in accordance with the terms thereof, by U.S. Regular Mail and by publication in the **Shelby County Reporter**, a newspaper of general interest and circulation published in Shelby County, Alabama in its issues of **April 8, April 15 and April 22, 2009**, and,

WHEREAS, on **May 6, 2009**, the day on which the foreclosure sale was due to be held under the terms of said notice between the legal hours of sale, said foreclosure sale was duly and properly conducted, and Regions did offer for sale and sell at public outcry, on the steps of the main entrance of the Shelby County Courthouse, located at Main Street, Columbiana, Alabama, 35051, the property hereafter described; and,

WHEREAS, the highest and best bid obtained for the property described in the aforementioned Mortgage was the bid of Regions in the amount of \$483,800.00 which sum [**X**] was offered to be credited on the indebtedness secured by said Mortgage, *or* [] the said purchaser paid in cash, and said property was thereupon sold to Regions; and




