FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 26th day of March, 2008, Jane O. Smith, a married woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registrations Systems, Inc., acting solely as nominee for First Federal Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080331000129150 and re-recorded in 20080429000175370, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., ("Transferee"); and

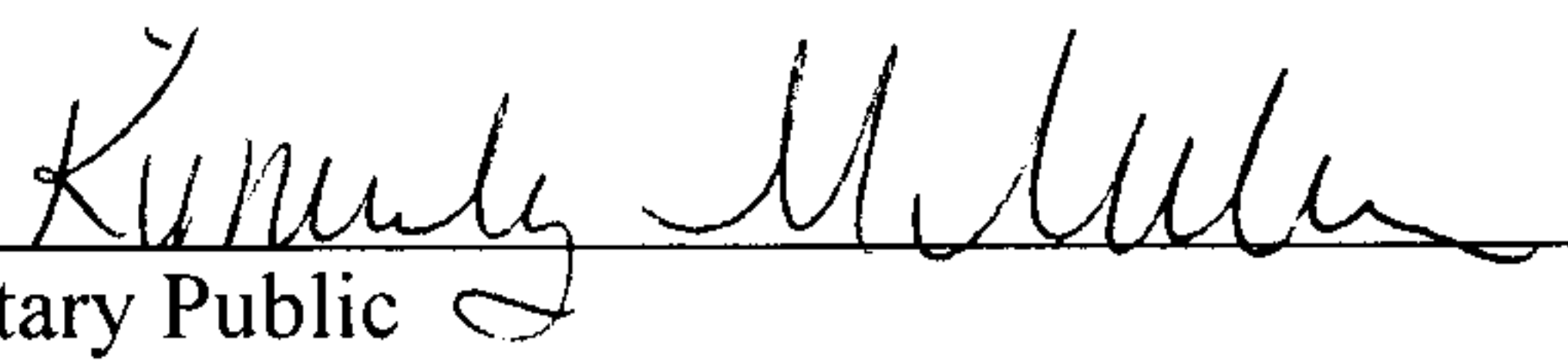
