KNOW ALL MEN BY THESE PRESENTS that in consideration in the sum of One Hundred Thirty Thousand and 00/100 Dollars (\$130,000.00) paid by the Grantees herein, the receipt of which is hereby acknowledged, Billy J. Hughes, a single person, (herein referred to as "Grantor"), does grant, bargain, sell, and convey unto James Dyer and Peggy Dyer, husband and wife (herein referred to as "Grantees"), as Joint Tenants, with right of survivorship, all of their right, title, and interest in the following described real estate, situated in Shelby County, Alabama, to wit:




